2. Renewals (Class C Tavern Licenses)

- 1B01
 - Takoda- 715 Florida AVE NW
 - Uproar- 639 641 FLORIDA AVE NW
 - Commissioner Behna noted that he had spoken with 1B01 Commissioner Handerhan and he had no concerns about these renewals
 - Commissioner Behna noted that there were no complaints in our feedback form
 - Patrick Nelson asked if Uproar had two settlement agreements. Commissioner Behna stated that was incorrect and that those issues were taken care of in February 2021 when a settlement agreement was reached with Uproar. Uproar has a strict and recent settlement agreement.
 - Patrick Nelson went off video to research. Upon return, he noted that Commissioner Behna was correct and he was mistaken.
 - The committee discussed these two renewals and took no action

- Maydan- 1346 FLORIDA AVE NW
- Commissioner Behna noted that he spoke with 1B04 Commissioner Thomas who said she had no concerns. He also noted that Maydan has an existing settlement agreement with the Meridian Hill Neighborhood Association and that ANC1B is protesting the new license of a sister restaurant Tawle across the street.

- Commissioner Behna noted that there had been community feedback about trash in tree boxes near Café St. Ex
- Commissioner Harris noted that it is hard to pinpoint exactly where this trash comes from as it's a highly trafficked area. Commissioner Harris noted she would reach out to the businesses directly about trash.
- Commssioner Harris noted there had been an issue with the streetery at Compass Rose but it was not an ABRA issue and had already been flagged for proper people
- The committee took no action on these renewals

 - Commissioner Behna noted that there haven't been any issues with Wet Dog, but it has been 5 years since they signed the agreement
 - They filed a petition to terminate the settlement agreement unilaterally
 - Commissioner Orlaskey noted that when Wet Dog opened there was a lot of concerns about noise and there are many noise mitigation measures like a canopy as a result
 - Commissioner Behna noted that the attorney for Wet Dog did not do their due diligence to reach out to the ANC. Commissioner Orlaskey received an email but the email was about a different establishment Hook Hall but the attachments referenced Wet Dog
 - Evan Schlom noted that the petition states that they want longer outdoor hours
 - Evan Schlom advised that the motions for the renewal and the petition should be separate
 - Patrick Nelson noted that there was a lot of work that went into the original negotiations
 - Commissioner Behna read comments from the chat from Commissioner Kensek related to if the ANC had reached out to the condos right there. Commissioner Orlaskey said he had been in touch with several members of the condo building
 - Frank Chauvin noted that this is a residential area and late hours should not be permitted. Establishments need to be respectful in a residential area.
 - Commissioner Orlaskey motioned that the committee recommend that the full ANC protest the petition to unilaterally dismiss the settlement agreement for Wet Dog. Frank Chauvin seconded. The motion passed unanimously.
 - Commissioner Orlaksy motioned that the committee reccoemnded that the full ANC protest the petition on grounds of peace, order, quiet and all applicable grounds including noise from the outdoor space and concerns about trash. The motion passed unanimously.
 - Commissioner Harris noted that the ANC needs to be specific on wording because

 jurisdiction over them.
 - Frank Chauvin clarified that the ANC doesn't have any say on streeteries for the time being because

 - Patrick Nelson noted that there had been issues with the addition on the back of the building that came before ZPD not being up to code. He also noted that there was discussion at HPRB that it should have never been approved.
 - Patrick Nelson and Frank Chauvin noted there was debate about whether it's a summer garden or actually an addition of interior space
 - Evan Schlom noted that for ABRA purposes, the only qualification for a Summer Garden is that It's private outdoor space whereas a sidewalk café is public space
 - There is also concern that that if this is actually indoor space, there is a capacity

- Karen Gaal noted that it could be a pandora's box of redefining what spaces are summer gardens and which aren't
- Frank Chauvin noted that the underlying issue is also noise and disruption of the neighbors.
- Commissioner Behna noted that ABRA had found Mirror Lounge in violation.
- Commissioner Orlaskey motioned that the committee recommend that the full ANC protest the renewal based on peace, order, quiet and all applicable grounds including hours of the summer garden, noise in the summer garden, public safety and security, and compliance with DCRA regulations. The motion passed unanimously.
- Ghion Restaurant and Lounge- 2010 9TH ST NW
 - Commissioner Orlaskey had no feedback
 - Commissioner Behna noted they had no outdoor space
 - Frank Chauvin noted that the operator is very responsible and a good neighbor

- Commissioner Behna noted that while his term was ending, he would ensure the next committee chair receives all the documents

- Commissioner Behna noted that he communicated the committee's concerns about the
 potential meeting with the Office of Nightlife and the 9th street business owners. They
 decided to cancel the meeting
- Commissioner Behna noted that he had met with 2 attorneys for assistance with ABRA issues and the ANC
- Karen Gaal urged that any attorney is thoroughly researched and that the ANC has sufficient funds for this purpose
- Patrick Nelson inquired about what happened with District Sports bar and if a settlement agreement would be reached. Commissioner Orlaskey said he would reach out and follow up.

 - Erecting a memorial plaque

- Long Term
 - As part of redevelopment, change the context of the alley to act as a front door, as opposed to a back alley

Meridian Hill/Malcolm X Park Transfer To District Control

WHEREAS Meridian Hill/Malcolm X Park is a critical green space and community gathering space for communities in ANC 1B, Ward 1, and the District as a whole,

WHEREAS excluding Rock Creek Park, Meridian Hill/Malcolm X Park is the largest urban park in Ward 1.

WHEREAS the National Park Service's (NPS) maintenance, renovations, and overall upkeep of Meridian Hill/Malcolm X Park is woefully inadequate due to chronic underfunding and understaffing of NPS,

WHEREAS half of Meridian Hill/Malcolm X Park is currently inaccessible due to an NPS renovation project that is currently facing long delays,

WHEREAS the District's lack of statehood and full representation in Congress does not allow it to influence the NPS budget and staffing, negatively impacting the park's long-term planning,

WHEREAS the nonprofit organization Rock Creek Conservancy handles a large portion of the day-to-day maintenance of Meridian Hill/Malcolm X Park and relies on fundraising to do so

WHEREAS the Friends of Malcolm X Park are a key stakeholder group that organizes, maintains, and fosters community activities in Meridian Hill/Malcolm X Park

THEREFORE, BE IT RESOLVED that ANC 1B requests that Congresswoman Eleanor Holmes Norton urge the National Park Service to transfer the land of Meridian Hill/Malcolm X Park to the District of Columbia,

THEREFORE, BE IT RESOLVED that ANC 1B requests that Council-member Nadeau introduce a sense of the Council resolution in support of this transfer,

THEREFORE, BE IT RESOLVED that ANC 1B requests that Council-member Nadeau seek funding in the FY2024 budget, or whichever budget follows the approval of the land transfer, sufficient to cover the cost of purchasing the land,

THEREFORE, BE IT RESOLVED that ANC 1B requests that Council-member Nadeau seek to fully fund the budget of the Department of Parks and Recreation to ensure that that Meridian Hill/Malcolm X Park is fully restored and maintained,

WHEREAS, "moveDC is the long-range transportation plan for the District of Columbia," which "establishes goals, policies, strategies and metrics for District Department of Transportation (DDOT) to invest in transportation facilities and programs that address the future needs";

WHEREAS Neighbors with physical disabilities have identified issues with getting out of cars through protected bike lanes, |

WHEREAS Section 3 would have a larger impact to the design of the street and DDOT should coordinate with ANC 1B to hold a public meeting to hear concerns and support from community members.

THEREFORE, BE IT RESOLVED that ANC 1B is fully supportive of sections 1 and 2 of the proposed PBL improvement plan, shown to the ANC at the October Transportation Committee Meeting, and encourages DDOT to include raised crosswalks, continuous sidewalks, at extended sidewalks at bus stop locations (similarly to what is seen on K Street NW),

BE IT FURTHER RESOLVED that ANC 1B strongly urges that DDOT work closely with DCPS to ensure the design is safe for children riding to and from school in the section of 11^{th} Street NW, north of Florida Avenue NW.
