June 30, 2023 Re: Q3 FY23 1B Allotment

In accordance with D.C. Code, Section 1-309.13, the Office of the Advisory Neighborhood Commissions (OANC) reviewed the 1st guarter FY23 financial report for ANC 1B.

The OANC recommends withholding \$1,000.00 from ANC 1B's 3rd quarter FY 2023 allotment of \$6,011.01 based on our findings, as indicated below. The ANC is therefore entitled to receive \$5,011.01 from the 3rd quarter allotment.

The ANC must correct these findings by Tuesday, September 5, 2023, to reinstate any portion of the allotment.

The expense is assigned with category code 9 (Miscellaneous) in the check register. The note on the canceled check identifies this expense as "Holiday Market."	
The ANC must clarify if this expense is a	
sponsorship, a grant, or an activity of the ANC.	
The ANC must submit the 1Q23 Minutes. Pursuant to DC Code 1-309.13 (j) (1)Each quarterly report shall includethe minutes of all meetings indicating the Commission's approval of disbursements during the period covered by the quarterly report	
The ANC submitted the minutes approving the quarterly reports. However, the Office of the District Auditor (ODCA) requires that ANC submit the minutes of all meetings held during the quarter.	

With the release of this allotment, the ANC has \$8,011.00 remaining from the annual allotment of \$27,100.91.
