• Commissioner Behna moved the appointment of a Special Committee to review the allegations, present findings to Commissioner Kensek for a response and consolidate a report of findings, response, and recommendations to present at the ANC 1B November monthly meeting.

Allegations:

Commissioner Alan Kensek, 1B05, violated the ANC 1B Code of Conduct, DC Government Ethics Standards, and potentially campaign finance and elections rules.

- 1) Commissioner using an official position for priority access to establishments on U St and 14 St area.
- 2) Commissioner refusing to leave when ask or at closing to leave the premises given their Commissioner status.
- 3) Commissioner banned from local bars and taverns due to behavior.

- 3) Inflammatory and demeaning emails to other commissioners, continued after being asked to stop.
- 4) Disruptive behavior at meetings and appearing intoxicated, continued after being asked to stop.
- 5) Verbal and digital attacks on Commissioners, continued after being asked to stop.
- 6) Use of government assets for campaigning, continued after being asked to stop.

The OAG guidance for censure is to conduct an open process and allow adequate time for response to the findings. The Special Committee will review the allegations, present findings to Commissioner Kensek for a response, and consolidate a report of findings, response, and recommendations to present at the ANC 1B November monthly meeting.

1. Welcome, Roll Call and Introduction of Members

- 2. Guest Speaker: ABRA Director Fred Moosally (Link to view discussion with guest speaker https://us06web.zoom.us/rec/share/X7y90vLpDnu028W7UrxIsu340qg jPO7U-mAxwLzMbr755wtKBtOQVtf7quIc6Wa.NHdde8zaRC2WdQVw (Passcode: cd+Pc0q?)
 - Commissioner Behna introduced Director Moosally and asked a question related to joint enforcement when ABRA notices violations under other agency jurisdictions like fire code, DCRA, etc.
 - Director Moosally noted that they will either do joint enforcement actions or refer to the agencies after the fact
 - Commissioner Behna asked how an average citizen can follow up on a violation they report
 to ABRA because it's not easily trackable. Director Moosally advised citizens to contact ABRA
 Community Resource officer Sarah Fashbaugh at sarah.fashbaugh@dc.gov
 - Frank Chauvin asked a question about license holder contact information on renewals.
 Director Moosally said that ABRA is working on adding that information to placards and stated that ABRA is working to overhaul it's whole data/website records system.
 - Frank Chauvin asked about the ABRA inspector checklist and lack of consistency of items that are evaluated. Noted a specific example of a possibly illegally constructed summer garden.
 - Patrick Nelson noted there is nothing in ABRA code that explicitly defines summer gardens and there is wide variation.
 - Director Moosally noted that as far as ABRA is concerned Summer Garden is private outdoor space and Sidewalk Café is public outdoor space.
 - Commissioner Behna noted that better coordination would be needed between ABRA and DCRA, in particular related to the Office of the Zoning administrator and the arts overlay percentages. Additionally, running into issues with bars requesting increase in capacity and ABRA just deflecting the issue to DCRA rather than evaluating crowding in the area
 - Director Moosally noted that if DCRA determined occupancy is less than what is in a settlement agreement, ABRA will enforce that lower number. And conversely, if the settlement agreement capacity is lower than the DCRA determined capacity, ABRA will also enforce that lower number
 - Commissioner Behna noted that it was a bigger issue when the establishment is specifically
 going up for a substantial change to increase capacity, and ABRA essentially just defers to
 the DCRA Cert of occupancy
 - Patrick Nelson gave a specific example of an establishment with an outdated C of O

- Commissioner Orlaskey noted that the ANC has had challenges with settlement agreements and the ANC not being successful in protest hearings because the board is unwilling to consider impacts on a neighborhood scale. Establishments also have lawyers and always seem to win and will get out of settlement agreements. Not much leverage or resources for the ANC.
- Director Moosally noted that there is a contested case process and a moratorium is also a possibility, not necessarily recommending it.
- Evan Schlom noted that he has never seen an application denied or only granted in part if there is no protest. How does ABRA evaluate unprotested new licenses, renewals, substantial changes, etc.
- Director Moosally noted that settlement agreements are reviewed, have the owners been barred from holding a license, are there concerns about the location, is it near a school, is there a zoning issue, etc.
- Evan asked about what can be done to ensure violations can be enforced. Director Moosally
 noted that having clear settlement agreement was important. General provisions are harder
 to enforce. "No noise heard outside the establishment" versus "Establishment will take best
 efforts to minimize noise". Director Moosally also referred to Kimberly Johnson in the OAG's
 office
- Karen Gaal brough up a concern about establishments that have a huge list of ABRA violations and they can easily pay them and keep causing harm in the community. Is it possible to add stiffer fines or another tier of fines?
- Director Moosally noted that ABRA is always working with the council on fines. ABRA can shut places down and also do a \$30,000 fine plus 30 day shut down. He also noted that a serious act of violence can bring a penalty right away, doesn't need to be a repeat offender. Chief of Police can also close an establishment for 48 hours.
- Commissioner Harris asked more about the overhaul of the public facing website and records search. Noted it's very difficult to find settlement agreements and other records. Director Moosally noted again that ABRA was working on this. In November ABRA will also be adding every endorsement that the establishments have on the website.
- Commissioner Harris also asked about the World Cup emergency legislation. Director
 Moosally clarified that although hours of operation are extended, it does not override
 settlement agreements and does not impact entertainment hours. ABRA will also step up
 enforcement on establishments who apply for it.
- Frank Chauvin asked for the Director to follow up with 4 cases of over concentration. And
 asked if ABRA board members were available for public education/meetings. Director
 Moosally noted that as long as no more than 2 board members attend, it's okay and ABRA
 will also have training sessions at the beginning of the year.
- Commissioner Kensek in the attendees asked a question about what the benefit of signing a settlement agreement would be. Commissioner Behna noted that the benefit is that the establishment is being a good neighbor and setting expectations. ABRA encourages settlement agreements to avoid future issues.

 - o Tawle was represented by Attorney Sidon Yohannes and manager George Sault
 - George Sault noted that this establishment is affiliated with Maydan across the alley and also Compass Rose.
 - George Sault noted that the concept is still being developed, but want to make it more
 of a community gathering type establishment that they don't have capacity to do at

3. Update on 1840 7th Street NW (property across from Shaw-Howard Metro)

- Presentation from development team, which included Troy Balkema from Quadrangle Development Corporation and Billy Eckhardt along with property owner Howard University reps Joe Leonard a Derrek Niec-Williams
- Demolition of existing building to start next week and construction to take approximately 24 months (Delivery late summer 2024)
- Key features:
 - Will be 204 units including 14 IZ units, 20 additional affordable units on top of IZ
 - o Approximately 70-75% studio and 1 bedroom, rest is 1BR/Den & 2 bedroom
 - o 75 parking spots estimated (for residents primarily)
 - o Approximately 15,000 square feet of retail

3. 1250 U St / Alley lots NW (ARTS-1/RF-1) East Banc / Nate Klass (Square 274 / Lots 133, 804 - 820, 57 -61) SMD 1B-12 Sabel Harris. Brief review of benefit package data for the Consolidated Planned Unit Development (PUD) and Zoning Map Amendment project of residential/commercial building at 1250 U St and residential units on alley lots behind. Since last mtg we have received notice that our set down hearing has been set for Nov 10 at 4pm. The zoning commission will discuss the application no input from developer or community, and they will decide if it is fit for public hearing. Then a pre-hearing submission will be done and hope that the hearing will occur sometime in Feb 2023. The u street association met last weekend to discuss benefits program and we are waiting to receive the input that came from that event. We then will start to narrow down the "list" of 20+ items to what we think will work best for the application. We have made good progress on the art proposed projects for the site and are working to do rfp's. Memorializing the U st and temperance alley history and are working with Prof Grant from Howard Univ involvement on the project, and a dc-based art curation company metallic territorial on drafting the rfp's and want to get done by the pre-hearing submission. Still working with DDOT on bus stops and info screen. Spoke with DPR and need to work a bit on what if any "programing" can be done. They have idea for the rec center that they are moving on. Working on the landscaping ideas for the alley area will give update once I get specifics. We are still waiting to hear about the bid idea with the Brookings Intuition. There is further discussion on this idea that it needs to be looked at as place management to expanding the scope past just a bid. We need to keep in mind that this need to be self-sustaining. Maybe a study would be more in line. We are looking at the idea for public bathrooms. Need to determine the feasibility both space wise and management of them. Looking at the stone furniture for the plaza and need to work with metro on that. Karen – as far as dpr need to look at items that can be used such as tables, performance stage (permanent items). In response to the question about parking we anticipate that more people who will live here will not have cars but are in a

partnership with the owners of the Ellington across the street and proposed rent the excess spots that they have if needed by someone in our building. Next steps we will have a public meeting on Oct 25 to continue discussions. Will return next month.

4. 2730 Georgia Ave (MU-4) Howard University (Square 2885 / Lot 113) SMD 1B-09 James Turner BZA Case 20837 Hearing Date 12.21.22. Special Exception matter of right uses of Subtitle U § 512 (pursuant to Subtitle U § 513.1 (E) and Subtitle X § 901.2), to allow for food delivery use in existing, detached, onestory commercial building in MU-4 zone. We are looking to relocate the Sodexo food service/catering from the "HERB 1" building on 7th street that is being redeveloped and needs to move to another location. This building owned by Howard was at one time a food service establishment, so it is best fit for the needs of the Sodexo group. This would be used to prepare the food needed for campus activities. It is a 7-day working week depending on what are needed on campus. Deliveries are made daily, and trash would be three times a week (more if needed). Along the alley side of the site there is a retaining wall that is 4 feet and in the regulations state that it needs to be 12 inch thick 6 feet high brick wall to separate the mu-4 from the rf-1. We could ask for a variance to use the wall that is there or build a new wall inside the existing wall. Frank – this property is outside of the campus plan and is owed by the university? The answer is yes to both, and it was previously rented to Enterprise car rental. I have concern about the fact that it is losing its connection to the street and can there be something (food truck/venders) done to liven it up. The question is whether the proposed use really activates the street scape or just a "back office" use. The long-term plan for this is not site has not been determined this would be interim use. Tony - Will there be any demolition or construction and is there enough parking on the site for their needs. Only if we have to build the wall and the parking on site will be enough. Dr Leonard – Frank if you are talking about improving the building from street view (painting) we should look into that. Frank – yes that would be an idea to consider. Brad – is there a larger master plan for this site. The university should not plan on keeping it this way indefinitely. There are other opportunities for upgrading of this site but nothing right now is being planned. Jason – If this is temporary do you know where you plan a permanent site to house them on campus. The future location is in the proposed student union building not on the plan to do at this point of time. Chair – so I just want to say that I would suggest abiding by the regs and request the wall be constructed so as to minimize conflict with the butting neighbors. I would suggest also looking into the possibility of putting a netting cover on the Girard Street side fencing with artwork on street side to enclose the site. Then if there is no further discussion the chair moves that the committee recommends to the full ANC it support the applicants request for a special exception matter of right use to allow for food delivery use in existing, detached, one-story commercial building in MU-4 zone. It further requires the applicant adhere to the zoning requirements for the wall on the alley (be constructed at lot level), the exception be in place for period of 5 years, extended an additional term upon bza approval and the fencing along the Girard Street side of lot covered with art wrap. WHEREAS, "moveDC is the long-range transportation plan for the District of Columbia," which "establishes goals, policies, strategies and metrics for District Department of Transportation (DDOT) to invest in transportation facilities and programs that address the future needs"¹;

WHEREAS, DDOT approved the moveDC plan in January 2022 including a bicycle priority network on 15th Street NW from the Tidal Basin to Irving Street NW,

WHEREAS the 15th Street NW cycle track is one of the highest used cycle tracks in the District of Columbia and often experiences significant cycle traffic and congestion,

WHEREAS 15th Street NW is an excessively wide road with three one-way travel lanes north of Rhode Island Avenue and two parking lanes in addition to the cycle track and sidewalk,

WHEREAS numerous segments of the sidewalk on 15th Street NW are excessively narrow and not suitable for mobility challenged pedestrians,

THEREFORE, BE IT RESOLVED that ANC 1B requests that DDOT evaluate and create plans to widen and expand existing sidewalk facilities on 15th Street NW from Euclid Street NW to Eye Street NW to accommodate increased traffic,

BE IT FURTHER RESOLVED that ANC 1B encourages DDOT to evaluate and create plans to widen existing sidewalks on 15th Street NW in tandem with an expansion of the cycle track or consideration of a multi-use path,

BE IT FURTHER RESOLVED that ANC 1B encourages DDOT to present any bike infrastructure proposals at an ANC 1B meeting, or similarly sized public meeting that overlaps with the entire 15th Street NW area.

Meridian Hill/Malcolm X Park Transfer To District Control

WHEREAS Meridian Hill/Malcolm X Park is a critical green space and community gathering space for communities in ANC 1B, Ward 1, and the District as a whole,

WHEREAS excluding Rock Creek Park, Meridian Hill/Malcolm X Park is the largest urban park in Ward 1,

WHEREAS the National Park Service's (NPS) maintenance, renovations, and overall upkeep of Meridian Hill/Malcolm X Park is woefully inadequate due to chronic underfunding and understaffing of NPS,

WHEREAS half of Meridian Hill/Malcolm X Park is currently inaccessible due to an NPS renovation project that is currently facing long delays,

WHEREAS the District's lack of statehood and full representation in Congress does not allow it to influence the NPS budget and staffing, negatively impacting the park's long-term planning,

WHEREAS the nonprofit organization Rock Creek Conservancy handles a large portion of the day-to-day maintenance of Meridian Hill/Malcolm X Park and relies on fundraising to do so

WHEREAS the Friends of Malcolm X Park are a key stakeholder group that organizes, maintains, and fosters community activities in Meridian Hill/Malcolm X Park

THEREFORE, BE IT RESOLVED that ANC 1B requests that Congresswoman Eleanor Holmes Norton introduce a bill in Congress to authorize the sale of Meridian Hill/Malcolm X Park to the District government,

THEREFORE, **BEIT RESOLVED** that ANC 1B requests that Congresswoman Eleanor Holmes Norton attach this legislation to legislation authorizing the sale of RFK Stadium to the District,

THEREFORE, **BE IT RESOLVED** that ANC 1B requests that Council-member Nadeau introduce a sense of the Council resolution in support of this transfer,

THEREFORE, BE IT RESOLVED that ANC 1B requests that Council-member Nadeau seek funding in the FY2024 budget, or whichever budget follows the approval of the land transfer, sufficient to cover the cost of purchasing the land,

THEREFORE, BE IT RESOLVED that ANC 1B requests that Council-member Nadeau seek to fully fund the budget of the Department of Parks and Recreation to ensure that that Meridian Hill/Malcolm X Park is fully restored and maintained,

THEREFORE, BE IT RESOLVED that ANC 1B requests that Council-member Nadeau seek to transfer maintenance responsibilities for DPR parks from the Department of General Services to DPR.

ANC 1B Special Committee Initial Report on Allegations Made Regarding Commissioner Alan Kensek, 1B05

At the October 6, 2022 ANC 1B Monthly Meeting, Commissioner Eric Behna, 1B08, made a motion to create a Special Committee ("Committee") to review the following accusations against Commissioner Alan Kensek:

- Commissioner using an official position for priority access to establishments on U Street NW and 14th Street NW areas
- 2. Commissioner refusing to leave when asked or at closing, citing their commissioner status
- 3. Commissioner banned from local bars and taverns due to behavior
- Inflammatory and demeaning emails to other commissioners, continued after being asked to stop
- 5. Disruptive behavior at meetings and appearing intoxicated, continued after being asked to stop
- 6. Verbal and digital attacks on Commissioners, continued after being asked to stop
- 7. Use of government assets for campaigning, continued after being asked to stop

Censure represents the ANC's official, public reprimand of a Commissioner's conduct. As noted in an October 18, 2022 from the Office of the OAG, "Censure proceedings must abide by the Advisory Neighborhood Commissions Act of 1975 ('ANC Act'), the ANC's bylaws, and (to the extent these two sources are silent) Robert's Rules of Order. An ANC may, 'at the Chairperson's invitation or on motion of any Commissioner,' censure a Commissioner in a public meeting for conduct that just took place in that meeting.' When the conduct at issue falls outside that context, 'charges must be proffered and a formal trial held before the assembly of the [ANC], or before a committee—standing or special—which is then required to report its findings and recommendations to the [ANC] for action."

The ANC 1B Code of Conduct Principles (adopted by vote of ANC 1B at the October, 2022 full ANC meeting) states that a Commissioner:

- Must refrain from any activities that may harm the Commissioner's or the Commission's integrity and reputation;
- Must act on behalf of the tenets of the ANC Oath of Office; and

Must use position and title only when acting in an official capacity.¹

Additionally, the ANC Handbook for 2021-2022 was sent to Commissioner Kensek at his ANC email address (1b05@anc.dc.gov) by Chair James Turner on March 12, 2022. The Handbook lays out requirements for ANC Commissioners including ethical requirements. Specifically, the Handbook states that ANC Commissioners may not

[u]se District of Columbia government resources . . . to support or oppose any candidate for elected office or to support or oppose any initiative, referendum or recall measure in the District of Columbia.²

To review these accusations, the Committee split them into three sections and reviewed evidence related to these allegations. This includes evidence that was proactively shared with the Committee after the ANC 1B Meeting. A recommendation will be made to the full ANC based on the findings of the Special Committee and your written response to this preliminary report (due 5 calendar days from receipt).

The accusations below are all under investigation by the Special Committee.

Section 1: Accusations 1 - 3.

- 1. Commissioner using an official position for priority access to establishments on U Street NW and 14th Street NW
- 2. Commissioner refusing to leave when asked or at closing, citing their commissioner status
- 3. Commissioner banned from local bars and taverns due to behavior

The Committee found several instances that related to these allegations.

On May 27, 2022, a representative from Nellie's Sports Bar (900 U St. NW) reached out to ANC 1B commissioners to inform them that Commissioner Kensek had been banned from the establishment for 60 days due to an incident that occurred on May 14, 2022.³ The Nellie's staff member informed the ANC that Commissioner Kensek had attempted to gain access to the upper level smoking area after it had closed. When confronted by security, Commissioner Kensek refused to leave and had to be forcibly removed from the premises by the security team. After the event, Commissioner Kensek called the bar manager of Nellie's multiple times, threatening staff, and claimed that he "didn't want to make trouble for them," insinuating that he would use his power as an ANC Commissioner to make it difficult to acquire the necessary ABRA licenses. Censure Committee members followed up with Nellie's staff in October to

confirm the allegations. Nellie's staff informed the Committee that Commissioner Kensek was a "repeat offender" and had "harassed staff" repeatedly.

On June 1, the owner of the bar Kiki (915 U St. NW), Keaton Fedak, informed Commissioner Behna that Commissioner Kensek had been in the bar and refused to leave when the bar was closing, arguing that the bar had to let him stay because Commissioner Kensek was an ANC Commissioner. Mr. Fedak also stated that Commissioner Kensek claimed to work with ABRA and that he would get the establishment in trouble with ABRA if they didn't allow him to stay and drink. Mr. Fedak had considered banning him from the establishment, but chose not to.

Since the motion was passed at the October ANC 1B meeting, other residents and local establishments have reached out to Committee members to say that they have had similar experiences with Commissioner Kensek. These include:

Phone call with bar staff⁴ who reached out after seeing the Barred in DC article "ANC 1B Investigating Allegations Against ANC Commissioner" published October 11, 2022 ("Barred in DC Article").⁵ This individual described Commissioner Kensek as a "repeat offender" who came in intoxicated after being served at other establishments, would order more drinks and get cut off, then berate staff. According to staff, he threatened to call the owner and cited his role as ANC. It was reported that Cmsr. Kensek also said something to the effect of the following: "Who do you think you are, I know owner [said name] I will give him a call." When [BAR] staff spoke to Commissioner Kensek the next day, he threatened the staffer's job. [Bar] Staff reports that Commissioner Kensek was banned from the establishment for a period of time but eventually allowed to return.

Correspondence with a bar patron⁶ who reached out after seeing the Barred in DC Article. This patron described an evening earlier this year in a bar on U Street in which Commissioner Kensek was extremely intoxicated and rudely interrupted their party on the back patio, taking a seat from a guest who had left to use the restroom. Per patron: "His speech was completely slurred as he interrupted two separate conversations at our table, mentioning (amongst a lot of gibberish) he was an ANC Rep. We first politely asked him to let us finish our conversation. When he continued we had to yell at him to leave us alone and stay out of our conversation. He stayed at our table, uninvited, for at least 10 more minutes. After a third reminder from our group he needed to stop interrupting us, he drunkenly stumbled away. His behavior was so egregious, it even attracted the attention of other guests at nearby tables and the bar staff." After that time, the patron reports witnessing similar behavior at the same location, e.g. regularly sitting with people uninvited, who ask him to leave because he is too intoxicated, and almost always mentions his ANC status when people ask him to leave them alone. Patron reports that owners of the bar had to have a conversation with Commissioner Kensek because of the number of complaints he was getting about him.

Another anonymous poster on the Barred in DC Article claimed that Commissioner Kensek had repeatedly sexually harrassed them to the point where they would not go to a certain establishment anymore to avoid him. The Special Committee sees this as a particularly disturbing allegation that, while not corroborated, bears mentioning here and a response from Commissioner Kensek.

Section 2: Accusations 4 - 6

- 4. Inflammatory and demeaning emails to other commissioners, continued after being asked to stop
- 5. Disruptive behavior at meetings and appearing intoxicated, continued after being asked to stop
- 6. Verbal and digital attacks on Commissioners, continued after being asked to stop

The Committee found numerous instances throughout Commissioner Kensek's tenure as a Commissioner in ANC 1B in which his actions during meetings and interactions with other commissioners had been disruptive and confrontational.

Outside of public meetings, the Committee found several incidents in which Commissioner Kensek has directed inflammatory and demeaning emails to the whole Commission primarily targeting Commissioners Eric Behna, Sabel Harris, and Amanda Farnan, and ANC 1B Chair James Turner. Over the past several months, the following interactions have occurred via email or text:

- On May 12, 2022, Commissioner Kensek texted Commissioner Behna threatening to "sanction him if he could" after a community meeting⁷
- On June 1, Commissioner Farnan, after receiving email complaints about behavior at Nellie's, reached out to Commissioner Kensek and recommended to him that he should not attend the Thursday meeting. Commissioner Kensek replied to all of 1B and Councilmember Nadeau and called for a recall of Commissioner Farnan⁸
- On September 1, 2022, Commissioner Kensek confronted Commissioner Harris via text message, stating that he would report her to BEGA (sic), accusing Commissioner Harris of doing this because she was upset with the elections results for the ward 1 Council primary, and claiming that she was preventing him from representing his constituents (sic), after Commissioner Harris muted and turned off the video of Commissioner Kensek who was being distracting and acting inappropriately during the September monthly ANC 1B meeting.⁹

- On September 17, 2022, Commissioner Kensek threatened Commissioner Behna with a "cease and desist," claiming that Commissioner Behna was slandering Commissioner Kensek.
- On September 21, 2022, Commissioner Kensek asked Commissioner Farnan about getting reimbursed for business cards he purchased on his own, prior to approval for funds to be released by the ANC, and referencing Commissioner Farnan's campaign signature challenge.¹¹
- On October 19, 2022, Commissioner Kensek harassed Commissioner Behna about not being able to get into the ABRA Committee meeting, accusing Commissioner Behna of trying to prevent him from participating in the meeting. Commissioner Behna informed Commissioner Kensek that he was already signed up for the meeting and his personal email was being used¹²

Within public meetings, the Committee found several incidents in which Commissioner Kensek exhibited disruptive behavior. Over the past several months, the following interactions have occurred during ANC meetings:

- May 12: The first instance of this behavior was at a public meeting hosted by NCBA on May 12 to discuss their proposed development in ANC 1A11. Commissioner Kensek appeared visibly intoxicated and asked nonsensical, unrelated questions. At one point, he requested to tour the construction site for the building to ensure its safety. Commissioner Behna witnessed Commissioner Kensek drinking a beer while he was on mute and, after telling him to wait till the end of the presentation to ask questions, Commissioner Kensek sent the above texts on the same date.¹³
- September 1: The second instance of Commissioner Kensek displaying inappropriate behavior at ANC meetings was at the September regular ANC 1B meeting, on September 1, 2022. Commissioner Kensek announced early in the meeting that he was attending an event for the Mayor. Mayor Muriel Bowser was hosting the kickoff event for 202Creates at District Pier, a bar in the Wharf. Commissioner Kensek would turn on and off his camera repeatedly, repeatedly interrupt the meeting, take selfies with other attendees, make faces on camera, and be a general nuisance. At one point in the meeting, Commissioner Harris turned off Commissioner Kensek's camera and muted him, to stop him from being a distraction to other panelists. Commissioner Kensek reacted negatively, confronting Commissioner Harris on September 1st, as mentioned above.¹⁴

Section 3: Accusation 7

7. Use of government assets for campaigning, continued after being asked to stop

In an email exchange that began on April 13, 2022 and ended on April 15, 2022, Commissioner Kensek offered campaign funds for Commissioner Harris' Ward 1 Councilmember campaign through his ANC email address. Commissioner Harris informed Commissioner Kensek that this was a violation of ANC ethics and that ANC email addresses should not be used for any campaign-related or political advocacy activities. Commissioner Kensek said that he did not know and that this would not happen again.

On June 9, 2022, Commissioner Kensek sent an email to the entire ANC 1B after announcing that he would be publicly endorsing Salah Czapary for Ward 1 Council. Immediately after the email, both Commissioner Harris and Chair Turner replied announcing that this was likely a violation of the Hatch Act and OANC ethical guidelines for using an ANC linked account for campaign purposes. Commissioner Kensek ignored the recommendation.

In emails referenced above in Section 2, throughout September and October, Commissioner Kensek has sent emails to Commissioners Harris and Farnan, mentioning previous campaign donations to Commissioner Harris in her campaign for Ward 1 Councilmember, and Commissioner Farnan's opponent in her bid for ANC Candidacy, Brian Footer, in ANC 1E.

The use of official ANC email addresses in order to conduct campaign activities or to advocate for particular candidates is a violation of the ethical standards of conduct for DC officials, including ANC Commissioners.¹⁵

Conclusion

The Special Committee is investigating the accusations presented herein. As Commissioner Kensek's response is a part of that investigation, the Committee will reserve any final conclusions or recommendations to the full ANC until after Commissioner Kensek has had an opportunity to respond to this initial report in writing within five (5) days of receipt of this initial report via email.

This is the most restrictive, least democratic suppression done in order to get a colleague to walk lock step with their oppressive corrupt actions. This is a deliberate slandering process that is being instituted because their uncivic actions and negligence to their constituents were highlighted based numerous false community complaints. All of the things that have plotted to bring forth conjecture of a bar room gossip answering favor in order to gain unlimited bar access and maintain his friendship with the accusing ANC member who also made multiple comments on his twitter account 20 days prior to these allegations being read on October 6th. Section 1: Accusations 1 - 3.

1. Commissioner using an official position for priority access to establishments on U Street NW and 14th Street NW areas.

This has *never* happened. This is simply gossip and an organization who has over 17 Investigation reports/citations from assault to police officers to patrons, against them, trying to come off in the public as law abiding business. I can count on one (1) hand how many times I have been at Nellie's during my 7 years of living in this great city, however being accused as a "repeat offender" is a blatant lie. If anyone is a "repeat offender" it is Nellie's and their establishment. I also have never "harassed staff" at Nellie's. The 1B constituents knows what Nellie's has done and have voiced many concerns even at our last in-person meeting October 6th, 2022. With all of these allegations about me using my Commissioner status in the "U" street area to gain access and it is now being brought up eight (8) months later, one (1) month before elections. No one from a news article writes about it. No one speaks about it until now. There is nothing notarized or signed. 2. Commissioner refusing to leave when asked or at closing, citing their commissioner status 3. Commissioner banned from local bars and taverns due to behavior.

As far as Keaton Fedak, the owner of Kiki, informing Commissioner Behna on June 1st that I refused to leave during closing time due to me being a Commissioner is not true and *never* happened. Furthermore, I find it concerning that this bar would take my money and well-paid tips as a patron and go to another acting commissioner and say these things about me. I have never said I worked with ABRA and if Kiki didn't allow me to stay, I would get them in trouble. This *never happened*. I am not on the Commission for ABRA and have been to two (2) meetings in the past two (2) months. This incident is stating June 1st is a lie. I have never been banned from Kiki and they certainly enjoyed my financial support during my few visits of this 1B local establishment.

Local establishments reaching out to the Committee members to say that since the motion was passed at the October ANC 1B meeting, other residents and local establishments have reached out to Committee members to say that they have had similar experiences with Commissioner Kensek is gossip and not true. "Barred in DC" is a TMZ/ National Enquirer type of online gossip column. It was meant to slander my character. I am not aware of being banned and allowed back in. This is 100% hearsay and that's all.

For a "supposed" patron to reach out after that nonsensical article is hard to believe. This did not happen.

I have *never* sexually harassed anyone in my life, which was added to the comments section based off of the "Barred in DC" article. Again, this supposed anonymous caller/writer is made up from the Commission to make me look bad. Just like the innocent comment of the date and time for the public special committee hearing.

They are alleging that outside of public meetings I have inflammatory and demeaning emails to the whole Commission primarily targeting Commissioners Eric Behna, Sabel Harris, Amanda Farnan, and Chair James Turner. I do not target anyone. I am persistent and the fact that over the past 8 months that these aforementioned individuals have bullied me and ignored emails I have sent, when asked by my constituents has been unacceptable and not fair. Especially if we are a "collegial body" as Commissioner Behna likes to say. As mentioned in the public meeting on October 6th, this commission has been the most untransparent body I have ever seen in my 7 years as a resident. Working with them over the past eight (8) months has been very difficult to get information to say the least. I asked since March to get business cards and had to purchase them on my own (Commissioner Farnan told me where they all had their cards done) in August. When I asked for reimbursement, I received this email on August 31st, 2022, from Commissioner Farnan;

"Hi Alan - It is not. We needed to approve funds to pay for cards. This item has not been added to the agenda.

The be frank, there is an open ethics investigation looking at your misrepresentation of what a Commissioner says and does. We are not in a place where business cards are an appropriate use of funds in this case.

Talk soon, **Amanda**

Amanda Farnan Commissioner, 1B11 Treasurer, ANC 1B (202) 525-7059"

Please note I have been asking for my cards since March and 1B has \$120,000 in the bank. Commissioner Farnan is the "Treasurer" and saved that much just so some of IB finances would get transferred to the new "1E Commission" that she is now running for. We all know 1B could have used those funds on a whole lot for our community! I have been asking her repeatedly for months what 1B monies look like and received vague answers. Almost like it was being held by not only my 1B05 constituents, but *all* of the constituents in 1B.

I have *never* been intoxicated on a call. I am always ready, prepared and engaging to handle my responsibilities as a Commissioner to ensure my constituents concerns are voiced and recognized. My constituents vote for me, not my fellow Commissioners. These allegations are because they take things personally and do not like me. When I first became a Commissioner, I treated Commissioner Orlasky, Commissioner Harris, Commissioner Farnan, and Commissioner Ewart out for drinks and dinner because I wanted to get to know them.

Commissioner Behna accusing me on 2 different incidents of being intoxicated while on a zoom call is not fair. In fact, in May of this year at Dirty Goose as they were closing, I witnessed along with others Commissioner Behna being held up by his partner and a bouncer leaving the bar and I said to him and I quote "Commissioner Behna, you shouldn't throw rocks when you live in a glass house." I also have said to him on a few occasions when you can't stand on your own two (2) feet that is the definition of intoxication. For the record, I do where my Invisalign 22-23 hours a day. Also not that it is anyone's business I also take heart 2 separate heart medications that are known to tire one. I don't feel comfortable sharing the photos of the 2 medications but will do so if the Special Committee would like me too, including my Invisalign box.

Commissioner Sabel blocked my camera and speaker on the zoom call on September 1, 2022. When I texted and asked her during the meeting, her response to me was "For your zoom it's nothing on my end". In the public meeting on October 27^{th,} she admitted she did blocked my zoom video, making her a liar. (Screen shot of Commissioner Harris saying the aforementioned)

The Commission says, "More recently, Commissioner Kensek has been requesting to be a panelist on various committee meetings". This is true to get a gauge of where we are at so when more than two (2) thirds of this current board retires/not running for reelection, or changes Commissions to 1A and 1E (due to the census, all areas have been rezoned). I can effectively carry on the duties for 1B.

Section 3: Accusation 7

Use of government assets for campaigning, continued after being asked to stop

I never intentionally tried to use government assets for campaigning. I will add that when Commissioner Farnan ran during her special election to become the 1B11 SMD representative. Commissioner Farnan put on a YouTube video of all Commissioners (even the outgoing 1B11 Commissioner Delaney) with the exception of Chair Turner, and had Commissioners say that Amanda Farnan is the right candidate and that constituents should vote for Commissioner Farnan. Even those on this Special Committee. Now that violates the Hatch Act and is very abusive of government assets for campaigning. Furthermore, when I asked *all* Commissioners about this, Commissioner Farnan deleted the video off her twitter page, and no one responded.

In conclusion I would like to share something that the Special Committee wrote, and I obtained on October 26 at 5PM EST, the day before the public meeting and before allowing me the 5 days to even respond. I have a copy of this and attached it as well so you can see in black and white what they already predetermined. This is the Special Committee's conclusion.

"Conclusion

The Censure Committee has reviewed the evidence provided. We believe that the evidence provided accurately corroborates the accusations put forward against Commissioner Kensek. While all of the accusations are accurate, the Committee does not believe that accusations four (4), five (5), and six (6) warrant a censure recommendation. However, The Censure Committee believes that accusations one (1), two (2), three (3), and seven (7) warrant a censure recommendation.

The accusations that warrant a censure recommendation violate ethical standards and potentially violate federal law. While ANC Commissioners have "great weight" in an advisory capacity, utilizing one's status as an ANC commissioner for personal gain is unethical and should be treated as a serious problem. While accusations four (4), five (5), and six (6) are not censure-worthy in a vacuum, they reflect poorly on Commissioner Kensek's character.

Additionally, since the motion was passed to begin the censure committee, several people have reached out to the ANC to provide additional evidence supporting the accusations, most notably in the comments section of <u>a blog post by "BarredinDC"</u> and in the replies on <u>Twitter</u>.

Commissioner Kensek forwarded us a draft document, which he also mentioned that he had discussed in the recent public special committee meeting. That document discusses the pending censure matter and contains language recommending a particular outcome in the matter. He indicated that the document has been shared both with commissioners on the special committee and with commissioners who are not on the committee. He has asked us to opine on whether the preparation and dissemination of this document undercuts the fairness of the process. This email responds to that request. In keeping with the carefully limited role of our Office in this type of matter, we go no further than to reaffirm the principle of fairness we have emphasized before. The ANC must pursue a fair process in which commissioners review the evidence before them with an open mind and avoid prejudgment or any appearance of prejudgment. We offer no opinion as to whether these requirements of fairness have been satisfied here.

Statement of Conclusion

Special Committee of ANC 1B to Review Allegations Against Commissioner Alan Kensek

The members of the Special Committee have reviewed the allegations of misconduct against Commissioner Alan Kensek and the evidence both supporting and opposing each allegation. The Committee would like to make it clear that the only remedy available to an ANC, if such allegations are found to be valid, is censure. Censure carries a penalty of an official condemnation of actions and a bar from serving on ANC Committees or executive positions for the remainder of a commissioner's term.

All evidence supporting the allegations below can be found in the Initial Report.

Commissioner Kensek submitted the following evidence in opposition with his Response.

Allegation:

- 1. The Special Committee voted (2 yeas, 0 nays, 0 abstentions) that the evidence presented, both for and against, is sufficient to show that Commission Kensek used his official position to coerce concessions from local establishments. Commissioner Kensek denied the allegations in his response as to only one establishment, he did not address corroborating evidence of his conduct provided in the Initial Report.
- 2. See Allegation 1 above.
- 3. The Special Committee voted (1 yea, 2 nays, 0 abstentions) that the evidence presented, both for and against, does NOT sufficiently show that Commissioner Kensek abused his position in being banned from certain establishments for his behavior.
- 4. The Special Committee voted (0 yeas, 2 nays, 0 abstentions)¹ that the evidence presented, both for and against, does NOT sufficiently show that Commissioner Kensek conducted himself in violation of the ANC 1B Code of Conduct or the rules of ethical conduct for an ANC Commissioner. While he did, on several occasions, show disrespect towards other Commissioners and conducted himself in a questionable manner during several official public meetings, the Special Committee believes that the circumstances and

evidence surrounding these exchanges do not sufficiently rise to the level of official censure.

- 6. See Allegation 4 above.
- 7. The Special Committee voted (2 yeas, 1 nay, 0 abstentions)² that the evidence presented, both for and against, is sufficient to show that Commission Kensek did violate prohibitions on Commissioners using ANC resources, including ANC emails and official public meetings, for political campaign purposes. This behavior was repeated after initially being advised that doing so is a violation of rules regarding conduct of a Washington, DC official (See Initial Report, Allegation 7).

In making its decision, the Special Committee members considered all evidence presented both for and against each allegation. While much of Commissioner Kensek's conduct has shown questionable judgment and a clear lack of respect for his fellow Commissioners, even conduct that many might consider abusive, the Special Committee ultimately decided that Commissioner Kensek's attempts at abusing his power as an ANC Commissioner, outlined in allegations one, two, and seven, necessitated a censure recommendation. By majority vote, the Special Committee believe that an official censure is warranted, as described above.

RESOLUTION OF CENSURE FOR COMMISSIONER ALAN KENSEK

WHEREAS; Commissioner Alan Kensek was certified and published in the DC Register to fill the Single Member District 1B05 vacancy as a single candidate having completed the petition and challenge periods for the vacancy;

WHEREAS; Under the Advisory Neighborhood Commissions Act of 1975 ("ANC Act"), an ANC does not have the power to regulate Commissioners except during ANC proceedings or when they are using ANC property including ANC email.

WHEREAS; ANC 1B has consulted with the Office of the Advisory Neighborhood Commission, the Office of the Attorney General, the Office of Government Ethics, the ANC 1B Code of Conduct, and the DC Code, among other sources, during this process.

WHEREAS; ANC 1B has been advised that ANC 1B has the authority to issue a resolution of censure if it finds sufficient grounds to do so after a full review of the evidence presented both for and against.

WHEREAS; Commissioner Kensek using his official position in order to coerce concessions from local establishments is a violation of ANC 1B Code of Conduct and DC rules for Advisory Neighborhood Commissioners.

WHEREAS; Commissioner Kensek using ANC resources, including his official ANC email and official public meetings of ANC 1B and its committees, for campaign purposes is a violation of D.C. Official Code §§ 1-1163.33 and 1-1171.01(8)(A) and is clearly stated in the Advisory Neighborhood Commissioners Handbook, 2021-2022.

WHEREAS; The Advisory Neighborhood Commission 1B Special Committee presented the allegation and supporting evidence to Commissioner Kensek in an Initial Report and allowed Commissioner Kensek to respond in writing within five (5) calendar days.

WHEREAS; The Special Committee has consolidated the allegations, evidence for and against, and Commissioner Kensek's response and sent this information to all Commissioners of ANC 1B for their review.

WHEREAS; The Special Committee recommended a vote be taken, yay or nay, on the question of whether to Censure Commissioner Kensek based on the information presented.

THEREFORE BE IT RESOLVED THAT: Advisory Neighborhood Commission 1B in accordance with the extent of its authority, its Code of Conduct, a majority vote of Commissioners present at the November 3, 2022 public meeting, and other governing documents hereby CENSURES Commissioner Kensek.
