Advisory Neighborhood Commission 1C Adams Morgan Minutes of January 4, 2023

I. Call to Order and Introduction of the Commissioners

A. A meeting of Advisory Neighborhood Commission 1C was held electronically on January 4, 2023. Commissioner Wood called the meeting to order at 7:00 pm. In attendance were Commissioners Lee Dixon (1C02), Peter Wood (1C03), Joe Van Wye (1C04), Margaret Stevens (1C05), Lynda Laughlin (1C06), Jake Faleschini (1C07), and Barney Shapiro (1C08). Members of the public joined electronically.

A. Sean Sullivan called for nominations. Commissioner Faleschini nominated Commissioner Wood for the position of Chair of ANC 1C. Commissioner Dixon seconded the nomination. Commissioners then voted 7 to 0 to elect Commissioner Wood as Chair.
