## Administrative Tasks:

- Agenda Approval
  - Commissioner Allison motioned to approve the agenda as amended to add public comment for the Bancroft resolution and consideration of a street lights grant; Commissioner Núñez seconded. The Chair called a voice vote, and the agenda was approved 6-0-0.

## Old Business:

- Letter on Prioritization of Traffic Safety Improvements at Brown and Monroe Street NW
  - Commissioner Allison introduced the letter. Commissioner Decker made a motion to approve the letter, the motion was seconded by Commissioner Núñez. The Chair called a voice vote and motion was approved 6-0-0.
- Resolution Supporting the Purchase of the Henderson Building for Bancroft Elementary
  - Commissioner Parbhoo introduced the resolution. Commissioner Willis made a motion to approve the letter, the motion was seconded by Commissioner Allison. The Chair called a voice vote and motion was approved 5-0-1 (Commissioner Núñez abstained due to a professional conflict of interest).

## New Business:

- Resolution on the Mt Pleasant Public Library Closure

- Commissioner Allison introduced the resolution. Commissioner Decker made a motion to approve the resolution, the motion was seconded by Commissioner Núñez. The Chair called a voice vote and the motion was approved 6-0-0.
- Grant Application – Mount Pleasant Street Lights
  - Commissioner Núñez made a motion to approve the grant in the amount of \$2,500 if the full remaining need is met from elsewhere, the motion was seconded by Commissioner Allison. The Chair called a voice vote and the motion was approved 6-0-0.
- Grant Application – Food for All
  - Commissioner Decker made a motion to approve the grant in the amount of \$4,000, the motion was seconded by Commissioner Willis. The Chair called a voice vote and the motion was approved 6-0-0.

**Treasurer’s Report:**

- Presentation of the FY24Q4 Quarterly Financial Report (QFR), which was approved by voice vote 6-0-0 following a motion by Commissioner Decker and seconded by Commissioner Núñez.

**Meeting Adjournment:**

With no additional comments or questions, Acting Chair Parbhoo requested a motion to adjourn. Commissioner Decker moved to adjourn the meeting, Commissioner Núñez seconded. The motion was approved 6-0-0 by voice vote.
