#### Consideration of CR-24-005, a Resolution Regarding DC Council Bill 25-0345 – the “Secure DC Omnibus Amendment Act of 2024”

Commissioner Omictin made a motion to adopt a proposed amendment to the resolution to add language regarding the sections of the bill that the ANC is concerned about. Chair Malec seconded the motion for the amendment, which was adopted by unanimous consent. Commissioner Chadwick made a motion to adopt a proposed amendment to the resolution to add language stating that the ANC supports the bill except for certain sections of the bill. Commissioner Patel seconded the motion for the amendment. Commissioner Omictin made a motion to adopt a proposed amendment to the amendment to the resolution to remove language stating that the ANC supports the bill except for certain sections of the bill. Chair Malec seconded the motion for the amendment to the amendment, which was adopted by unanimous consent. The final motion for the amendment was adopted by unanimous consent. Commissioner Omictin made a motion to adopt a proposed amendment to the resolution to fix the grammar regarding the language about the ANC’s concerns about the bill. Chair Malec seconded the motion for the amendment, which was adopted by unanimous consent. A roll call vote was requested. The final motion was voted on and passed (VOTES: 5-0-0).
