# ANC 3B Public Meeting Minutes August 8, 2024

Call to Order: 7:00 pm via Zoom

**Approval of Agenda.** Passes 5-0.

**Police Report**. Lt. Johnson reported no violent crimes in the past 30-day period. One burglary of an unoccupied residence occurred on W Street and there were 7 thefts from auto. The next community walkthrough in PSA 204 will begin at Connecticut and Calvert at 6:30 pm on August 24th. Commissioner Blumenthal asked about an incident at the Sheffield at 2320 Wisconsin Ave where police were called to do a welfare check. Two officers went to the building. Because there was no onsite manager or front desk, the officers left even though other residents told them how to enter the person's apartment. The person was discovered deceased by another resident the next day. Lt. Johnson will look into what went wrong.

## **Old Business**

**CANCELLED.** Amitie withdrew their application because of an irresolvable zoning issue. ANC 3B was to consider their application for becoming an internet-only cannabis retailer located in Glover Park at 2176 Wisconsin Avenue, Suite 100 (the southwest corner of Wisconsin and W Place).

#### **New Business**

**Liquor License Application for Maharaja, House of Biryani.** Commissioner Blumenthal said that Maharaja, a new Indian restaurant in Glover Park at 2414 Wisconsin Avenue, NW, has applied for a full liquor license with maximum hours (e.g., until 2 am on weekdays and 3 am on weekends). The owner had agreed to participate in the meeting but was not present. In August, the ANC asked for public comment on the license application, and no objections were heard. Commissioner Blumenthal made a motion not to protest their license application and let it go through for ABCA approval. The motion was seconded and passed 5-0.

As of October 1, the Circulator bus that runs between Holy Rood cemetery and Union Station will end service at 9 pm instead of midnight and buses will run only every 20 minutes. As of December 31, all service on this line will be terminated.

- The July minutes and transcript were presented for a vote and approved unanimously.
- Commissioner Lavezzo presented the financial report for July. The beginning balance was \$43,679.10 and the ending balance was \$41,465.59. One check was written for \$2,213.51 to the Glover Park Citizens Association to have the Potomac Appalachian Trail Club rehabilitate the Whitehaven Trail in Glover Park.
- Commissioner Lavezzo presented the third quarter report for FY 2024. The beginning balance was \$34,413.78. Deposits were \$11,955.63 from DC allotments. Withdrawals were \$2,500 for a grant and \$190.31 to pay an invoice. The ending balance for the third quarter is \$43,679.10. A motion was made to approve the report. It was seconded and passed 5-0.
