### Community clarification and discussion on the proposed plan to replace UDC -Van Ness Campus Building 41 with the DC Archives.

**A. UDC Building 41 -General Council, UDC, Avis Russell; Chief Operating Officer, UDC, David Franklin (7:04pm -7:11pm):** Avis Russell introduced herself to the call and discussed common points from the community about this issue. She included comments about the Van Ness Master Plan, Student Housing, and UDC Gardens Space.

**B. DC Archives Plan -State Archivist and Public Records Administrator for DC, Dr. Lopez Matthews (7:11pm -7:22pm):** Dr. Lopez Matthews gave updates on the plan and responded to concerns communicated to him. He brought up updates on parking, blueprints to show the DC Archives design, and public engagement opportunities.

**C. Questions & Answers (7:22pm - 8:25 pm)** Community members had a chance to ask questions and give their thoughts on the current plans with opportunities for UDC and the DC Archives to respond to them. Comments that were brought up were about Childcare, Student concerns, the importance of this regarding other HBCU's, opportunities for student engagement, student housing, the difficulty of the construction, how professors can use this building, budget of construction, environmental concerns, MOU's, impact of student life, UDC gardens and produce, final blueprint plans, demolition plans, zoning commission. Commissioners Huet and Carlson gave support for this project.
