received from residents concerning fighting, rats,
parking in the mornings, and elderly neighbors not
feeling safe in their homes given the use of the back
door to the establishment by patrons.

- The owner explained the security cameras on property, and committed to security barring the use of the back entrance.
- The Commission was not prepared to vote on a settlement agreement given outstanding concerns, which we would relay to the owner and continue to discuss.
