Commissioner Campbell,

1. Intersection of Arkansas and 16<sup>th</sup> Street, ANC 4C had previously voted for a notice of intent that was filed with DDOT for reconfigure of this intersection safety. Vehicular and Pedestrian traffic, recently a pedestrian was struck with minor injuries, as Notice of Intent remains open by DDOT a follow-up has been made by SMD 4E05.
2. DC Water has a program for Lead Pipe replacement homes on this block, were able to receive lead pipes replacement at no cost to homeowners. DC Water does have a open ticket that has yet to close, due to cold temperatures ticket has yet to close but it is in process for the 1400-1500 block of Upshur St.

Commissioner Barry,

1. Intersection at Iowa and 13<sup>th</sup> has been under traffic study's by DDOT. Intersection has been recessed again for Notice of Intent. The 1300 block of Buchanan St it is in discussion to become a one-way street.
2. WAMATA was scheduled to host a community meeting in mid-January to announce the electric buses meeting is scheduled for January 25<sup>th</sup>.

1. Referencing Commissioner Barry announcement on the Intersection at Iowa and 13<sup>th</sup>, there is talks about placing barricade in the middle it is yet unclear as to what that design would be will keep the public posted as more details are provided by DDOT.
