ANC 5C Business:

• Mechos Dominican Kitchen event approval (ABRA-114514) -

- Cmsr Hicks Delgado prefaces that this event needs ANC approval for a oneday permit because there is a protest ongoing
- Aris Compres of Mechos discusses the brunch event and the need
- Motion to approve passes unanimously by show of hands

• ABCA Cannabis licensing moratorium for Gateway/Arboretum -

- Cmsr Manning introduces the intent and reasoning behind this request
- Commissioners discuss various licensing types
- Cmsr Manning moves to request a moratorium for 5C04 on cannabis businesses, Cmsr Kapur seconds; passes 7-0
- (This vote was taken again on a detailed proposal in March, through the Resolution on Renewing, Refining, and Renaming the Langdon Park Moratorium Zone)

• Commissioner Concerns

- $\circ~$ Cmsr Thomas notes issues with the speedhumps on 2400 block of 17th St NE and disappointment with DDOT
- Cmsr Thomas notes Walgreens at 1401 Rhode Island Ave NE is proposing to close and proposes a town hall meeting
- Cmsr Dale notes issues with trash dumping on Banneker
- Cmsr Dale announces his resignation as the Commissioner from 5C01 and Commissioners note their dismay at his departure (this resignation was not ultimately completed, as announced subsequently)
- Cmsr Oliver notes concerns with DC PLUG work; Ann Walters is present to discuss

PUBLIC COMMENTS:

- 5C07 constituents voiced complaints about the content of 5B06/5C07 Joint SMD meetings
- Resident voices a complaint about children along South Dakota Ave not being safe from drivers, and Cmsr Thomas concurs and notes other instances
- Cmsr Manning asks Cmsr Kapur about Treasury reports and a brief report on monthly recurring expenses were discussed
- Cmsr Thomas shares some upcoming budget hearings
