### PRELIMINARY MATTERS:

**Call to Order** - Comm’r Rogers called the meeting to order at 7:06pm; Comm’r Manning had already indicated her absence.

### Regular Reports:

#### **MPD 5th District** (Lieutenant Devlin, Commander Altieri) -

- **Some technical difficulties with Lieutenant Devlin**, who was simultaneously on the 5B call
- **Commander Altieri** states 5D is doing relatively okay, down in many areas
- **Notes theft and motor vehicle theft** are driving crime, specifically the Hyundai/Kia issue and the steering wheel lock giveaway; notes they were donated by manufacturer and did not cost the taxpayer anything
- “12,000 or so of these vehicles in DC”; people are driving around looking for them and stealing them mostly for joyriding
- Commander Altieri says DMV did not share records with MPD but are pursuing their own notification solution
- Thefts are mostly from Home Depot and REI
- Officer Rodriguez from 5D won Officer of the Year for the whole Department
- Expanded crime suppression team
- **Lieutenant Devlin** notes some crimes in Saratoga

- Lieutenant Devlin invites questions; no questions

### **Councilmember Parker** (Carlos McKnight) –

- **At the end of Black History Month, CM Parker announced resolutions to give honorary street name designations**, honoring some famous African American Ward 5 residents and civic leaders
- **Discussed the child tax credit** that CM Parker introduced to “raise the economic floor” for our city and Ward
- **Discussed the Senior Advisory Committee** to give advice to the CM on issues that affect seniors in the Ward
- **CM Parker hosted a meeting on the W St bus depot** with Comm’r Oliver and EmpowerDC at Brentwood Rec Center; invited DDOT, OSSE, DGS. OSSE sent a representative and DGS has been in contact.
- **Carlos McKnight invites questions.**
  - **5C02 resident Roberta L.** asks about emails sent regarding a development, hoping that Carlos can be there. Meeting on Saturday 6pm.
  - **5C06 resident Linda Seabrook** remarks she was at the W St bus depot meeting, but had to leave because it was impossible to hear anyone including the Councilmember. Noted misrepresentations were made about the hours of construction. Mr. McKnight and Ms. Seabrook discuss following up over email.

### **Office of the Mayor** (nobody present) -

- **Commissioner Dale** notes last-minute notifications from MOCRS
- **Commissioner Rogers** notes she spoke to Christopher Ingraham earlier today and he said he planned to be at the meeting, and she was disappointed
- **Commissioner Thomas** says we should send a formal letter requesting MOCRS attention to meetings

### **Presentations:**

#### **Kimley Horn on behalf of Costco, PSC application 411742 -**

- Kimley Horn representatives brief the subject matter of Public Space Committee application 411742
- Various questions are asked and discussions had
- Community member Jamaica Kalika asked a question about increasing pedestrian safety as part of the project
- Commissioners discuss a vote with conditions; conditions are sorted out a document in real-time.

### **DDOT, Arboretum Bridge and Trail project -**

- Kyle Ohlson of DDOT presented the current status of this project and some preliminary design slides
- Comm'r Thomas notes safety concerns after dark; the trail won't formally be open after dark

### **Comm'r Kapur presents BZA 20872; 2026 Jackson St NE**

- Comm'r Kapur goes over the building history, design, and requested relief
- Comm'r Thomas asks about seeking party status; the issues with party status are discussed; 5C was the containing Commission when the case was opened but it was moved to 5B in redistricting. The Form 129 includes mention of seeking party status as needed.
- Comm'r Kapur moves to approve the report as drafted; passes 6-0

### **Discussion on Budget Request Resolutions**

- Comm'r Kapur has a resolution on arterial safety and bus service reliability; it's tabled
- Comm'r Dale offers to draft a comprehensive letter on budget priorities

### **PUBLIC COMMENTS:**

- Some additional discussion on the Costco issue, and the need to keep working on additional improvements

### **ADJOURNMENT:**

- Comm'r Rogers adjourns at 9:21pm
