Medicare and Medicare Advantage fee for service. On demand, 365 days a year between 8a and 10p. Can serve people as young as 3 months and older. Can be accessed via phone number. Can request care online. Covered by most providers at the cost of an urgent medical appointment (not emergency). With a board certified doctor can also assist. Ordered at the pharmacy as well. Team online to make sure we can address it to home or place of residence.
