1. CALL TO ORDER AND ROLL CALL

Jeanne Mattison provided updates from Councilmember Allen's Office relating to the Solar Shade Expansion Amendment Act of 2024, the Department of Parks and Recreation Field Priority Access Amendment Act of 2024, the 2024 Ward 6 Brickie Awards, and the WMATA Better Bus Program. 7. INTRODUCTION TO PLANNED DEVELOPMENT AT 471-473 H STREET NW (SMD 6E09)

Zachary Williams, Venable, LLP Law Firm Mark Freeman, Architect, Aggregate Architecture

Venable attorney Zachary Williams and the development team provided an informational presentation and drawings for a 46-unit affordable housing project at 471-473 H Street NW. A question-and-answer period followed.

8. DDOT NOTICE OF INTENT – NEW DEDICATED LEFT-TURN LANES AT 6TH AND K STREETS NW (SMD 6E01)

George Gurara, DDOT

DDOT's George Gurara provided a brief update on DDOT's Notice of Intent for safety improvements at 6th and K Streets NW per the following: **(1)** signal adjustment to add a new protected left turn phase; **(2)** creation of a new turning lane; **(3)** removal of parking spaces on 6th Street between Massachusetts Avenue and New York Avenue NW. A question-and-answer period followed.

MOTION: The Commission AGREED (5 yeas - 0 nays – 1 abstention) to SUPPORT the proposed safety improvements at 6th and K Streets NW and to convey that support to DDOT. (Motion by Commissioner Hart, Second by Commissioner Blackson).

9. LIQUOR LICENSE APPLICATION – LA BETTY, 420 K STREET NW (SMD 6E01) Tony Velasquez

MOTION: The Commission AGREED (6 yeas - 0 nays – 0 abstentions) to SUPPORT the liquor license application for La Betty, 420 K Street NW, and to convey that support to ABCA. (Motion by Commissioner Hart, Second by Commissioner Hans).

10. NOTIFICATION OF UPCOMING PUBLIC HEARING – ACACIA BUILDING HISTORIC DESIGNATION, 51 LOUISIANA AVENUE NW (SMD 6E08)

Commissioner Prince provided an update and stated the National Register of Historic Places will hold a virtual Public Hearing on December 19, 2024 at 9:00 a.m. and members of the public, stakeholders, and interested parties may submit testimony. ANC

6E provided a resolution in support of the nomination of the Acacia Building on February 27, 2024. Commissioner Prince provided relevant information regarding the Public Hearing in the Chat.
