- **Lieutenant William Hackerman** | Metropolitan Police Department (MPD) - Violent crime trending down; property crime doubled, mostly vehicle and other thefts; Violent crime reduction program PSA 607
- **Director DL Humphrey** | Constituent Services Director, Councilmember Vince Gray's office – Need school resource officers, requesting ANC put that in the budget; stress use of 311; ribbon cutting at 1900 C Street; agreed to ride along request to traverse Minnesota Ave, per request in chat; have to have 85% of signatures in the community before installing a speed hump;
