CALL TO ORDER: Meeting was called to order at 7:06 pm

ROLL CALL: Commissioner Bagley conducted a roll call. The following Commissioners were present: 7E01 - Katrina Norman; 7E02 – Krystal Bagley; 7E03 – VACANT; 7E04 – Natasha Dupee; 7E05 – Timothy Howard; 7E06 – Delia Houseal; 7E07 – Evette Lang. There were no Commissioners absent.

ADOPTION OF MEETING AGENDA: Commissioner Houseal motioned to adopt the January 2023 meeting agenda as presented via email to the commissioners and the 7E website. Commissioner Dupee seconded the motion and the motion passed 6-0.

ADOPTION OF DECEMBER 2022 MEETING MINUTES: Commissioner Bagley moved to adopt the December 2022 meeting minutes as presented via email to the commissioners and the 7E website. The motion was seconded by Commissioner Dupee. The motion passed 6-0.

CALENDAR YEAR 2023 OFFICER ELECTIONS: Moderated by Kathy Williams from the Office of Advisory Neighborhood Commissioners. Ms. Williams introduced herself to the audience and requested a motion to approve the Slate of Officers and Committee Chairs as presented, Chair – Delia Houseal, Vice-Chair – Natasha Dupee, Secretary – Krystal Bagley, Treasurer – Timothy Howard, Economic Development Committee Co-Chairs – Delia Houseal/Krystal Bagley, Education Committee Co-Chairs – Timothy Howard/Evette Lang, Public Safety Committee – Katrina Norman/Evette Lang, Transportation Committee – Krystal Bagley; Ms. Williams requested confirmation that all commissioners and committee chairs are eligible and willing to serve. - Commissioner Howard moved to approve Resolution 7E23-001 – Approval to Participate in ANC Security Fund - \$50 (Protects the ANC in the event of financial mismanagement; needed for ANC to spend money). Commissioner Dupee seconded the motion. The motion was approved 6-0.
- Commissioner Lang moved to approve the CY 2023 Public Meeting Schedule (Recess June, July, and December). Commissioner Norman seconded the motion. The motion was approved 6-0.
