Re: Q4 FY23 7F Allotment

In accordance with D.C. Code, Section 1-309.13, the Office of the Advisory Neighborhood Commissions (OANC) reviewed the 2<sup>nd</sup> quarter FY23 financial report for ANC 7F.

The OANC recommends withholding ANC 7F's 4<sup>th</sup> quarter FY23 allotment of \$5,082.33 plus \$14,461.73 in unsupported transactions based on our findings, as indicated below.

The ANC must provide the required documents by Tuesday, September 5, 2023, to reinstate any portion of the allotment.

The ANC has \$12,091.59 remaining after the 3Q23 allotment is issued. The OANC recommends a total deduction of \$19,544.06 (\$5,082.33+\$14,461.73) from the 4Q23 allotment. This will leave a balance of \$7,452.47. The remaining balance will be deducted from 7F's fiscal year 2024 allotments.

With these deductions, the ANC has \$0.00 remaining from the annual allotment of \$20,409.60.
