Re: Restore Q4 FY23 7F Allotment

In accordance with D.C. Code, Section 1-309.13, the Office of the Advisory Neighborhood Commissions (OANC) reviewed the 2nd quarter FY23 financial report for ANC 7F.

Albose

Based on our findings, the OANC recommended withholding ANC 7F's 4Q23 allotment of \$5,082.33.

Subsequently, the ANC submitted the signed 2Q23 QFR, the receipts/invoices, and the minutes approving the 2Q23 QFR. The OANC is disallowing the debit card expenditure of \$666.97 to Merchology because it is an impermissible use of ANC funds. **The OANC**, **therefore**, **recommends that the ANC receive \$4,415.36 from the 4Q23 allotment.**
