KIPP DC - Vanessa Gerideau	Making us aware of the event that they are having at Oxon Run Park this coming Saturday. Inflatables, music, cotton candy, etc. If it rains, event will be postponed.
Anne DeBuys - Chesapeake Climate Action Network	Project Pipes. Washington GAs replacement pipeline. Looking to charge customers \$4 billion for this project. 2014 - 2054. Has had over \$300 million has been approved, but Washington Gas is asking for twice that much for the next 5 years. This program is not affective and will have low-income residents paying for pipes that will no longer be used seeing that Washington, DC's plan is to go all electric. Lawrence Daniels would give us a balanced presentation to present to be against the Project Pipes Plan.
Guardian House - Chris Grant	REal Estate Developer. He owns three properties in SE and two properties in NE DC. Goal is to renovate, refresh and improve communities through real estate. 646 Chesapeake Street is the residence in question. They want to reposition the building and rename it The Guardian Response. A home designed mostly for firefighters, police officers and EMT's. They have hired someone by the name of Spearhead Solutions to provide with armed and unarmed security guards.

Commissioner Williams	Shooting at Stanton and Mississippi (Stanton Village Apts.) One killed. Two injured. Previous shooting two weeks earlier, but no one was hurt or killed.
Commissioner Moody	Update about the Highpoint HOA operating with a management company that is not licensed in Washington, DC
Commissioner Burrows	Has an SMD meeting to discuss rising rents and utilities. Prom dress giveaway as well; April 27th.
Tammy Hurt	Principal at The Washington Ballet School at THEARC. Here to discuss the ongoing violence near THEARC and the surrounding areas for the safety of our children. Looking for solutions to help detour crime.
