Per D.C. Code, Section 1-309.13 (j) (1), the Office of the Advisory Neighborhood Commissions (OANC) reviewed the 1st quarter FY23 financial report for ANC 8E.

The OANC recommends withholding ANC 8E's 3rd quarter FY23 allotment of \$5,768.84 based on our findings, as indicated below.
