ANC 1E CY2023 ANNUAL REPORT

Dear ANC 1E Community,

ANCs are required to submit an annual report summarizing the activities of the Commission in service to the community over the preceding year. The information below outlines issues voted upon, comments submitted to District agencies, and other key activities by ANC 1E in 2023. Additional details, such as meeting recordings, Commissioner bios, and community announcements, can be found on ANC 1E's website at www.anc1e.com.

ANC 1E was formed after the 2020 Census during the redistricting approved by DC Council on June 7, 2022 and approved by Mayor Muriel Bowser on June 16, 2022. The new ANC elected its first Commissioners in the 2022 election and took office on January 1, 2023. Therefore, the 2023 Annual Report reflects ANC 1E's first year in operation.

ANC 1E KEY HIGHLIGHTS:

- In January 2023, ANC 1E included 5 out of 7 Commissioner with Single Member District's 1E01 and 1E05 vacant. The 2 vacant seats were filled in early February and ANC 1E had a full Commission by the second meeting of 2023.
- ANC 1E hosted regularly scheduled monthly meetings the fourth Wednesday of the month except for November due to the Thanksgiving holiday, and met 11 times in 2023 that included a special meeting in March 2023. ANC 1E did not meet in August and December 2023.
- Between January 1, 2023 and November 29, 2023, ANC 1E and the community submitted 7,011 requests through 311, which is an increase of 591 requests compared to the same dates the year before (see Attachment A for a full breakdown).¹
- During ANC 1E's regularly scheduled monthly meetings between January and November 2023, the Commission welcomed 7 guest speakers and approved 66 resolutions and letters, including
 - 23 from Transportation and Public Space
 - o 20 from Zoning and Economic Development (including ABCA related issues)
 - 7 from Public Safety and Engagement
- ANC 1E received and approved 3 applications for sponsorships providing \$2,000 back to the community for events benefiting ANC 1E residents.
