ANC 1E CY2024 ANNUAL REPORT

Dear ANC 1E Community,

ANCs are required to submit an annual report summarizing the activities of the Commission in service to the community over the preceding year. The information below outlines issues voted upon, comments submitted to District agencies, and other key activities by ANC 1E in 2024. Additional details, such as meeting recordings, Commissioner bios, and community announcements, can be found on ANC 1E’s website at www.anc1e.com.

ANC 1E was formed after the 2020 Census during the redistricting approved by DC Council on June 7, 2022 and approved by Mayor Muriel Bowser on June 16, 2022. The new ANC elected its first Commissioners in the 2022 election and took office on January 1, 2023. Therefore, the 2024 Annual Report reflects ANC 1E’s second year in operation.

ANC 1E KEY HIGHLIGHTS:

- All 7 Single Member Districts’ were filled for all 12 months of the calendar year.
- ANC 1E hosted regularly scheduled monthly meetings the fourth Wednesday of the month, except for November which was pushed to the first week of December due to the Thanksgiving holiday. ANC 1E met 11 times in 2024 that included a special meeting in August 2024. ANC 1E did not meet in November 2024.
- Between January 1, 2024 and November 30, 2024, ANC 1E and the community submitted 6,453 requests through 311, which is a decrease of 418 requests compared to the same dates the year before (see Attachment A for a full breakdown).¹
- During ANC 1E’s regularly scheduled monthly meetings between January and December 2024, the Commission welcomed 11 guest speakers and approved 37 resolutions and letters, including
 - 13 from Transportation and Public Space
 - 8 from Zoning and Economic Development (including ABCA related issues)
 - 9 from Public Safety and Engagement
- ANC 1E received and approved 3 applications for grants or sponsorships providing \$5,800 back to the community for events benefiting ANC 1E residents.


