Advisory Neighborhood Commission 3C (ANC3C), at a duly noticed public meeting held on November 20, 2023, at which a quorum of Commissioners was present, voted with 7 yeas, 0 nays, and 0 abstentions with 1 recorded as absent to file this Annual Report with the Mayor of the District of Columbia (Mayor), the Council of the District of Columbia (Council), and the Office of Advisory Neighborhood Commissions (OANC), as well as publish this Report on the Commission's website. This Report covers Commission and Commissioner activities between November 2022 and November 2023 but excludes actions taken at the Commission's November 20, 2023, meeting given the Commission's vote to approve the Report at that meeting.

This has come after immense grief and the tragic loss of life of members of our community. I'd like to formally thank Dr. Chelsea Van Thof and other advocates, including Chairwoman Pagats for using their voices to get this done.
