- 2. 5A08: Convenience Store/Gas Station 4975 South Dakota Ave NE: Their hearing date has been moved. So, they will not be speaking tonight.
- 3. 5A08: McDonald's Development. Leila Battie- The applicant is proposing approval from Public Space committee, two curb cuts and then a wavier. Not changing the parking or site condition on the northern part of the property. Their proposal for the two curb cuts is more favorable to the

community. PSC is looking at site circulation. DDOT wants no curb cuts from South Dakota Ave. They wanted them on Delafield. DDOTs proposal is more burdensome on the community. DDOT also wants a higher density development, in spite of the fact that this community does not want that. May 25th Public Space meeting There will be beautification efforts made to the property. Lucio made a motion of Support for McDonald's Public Space Committee Application. Seconded by Tore. 3 in favor, 3 opposed. 1 abstention. Fletcher votes to support. The support for the application is approved and will move forward.
