Service

serve the remainder of her term as Delegate for Single Member District 5B05. While a Delegate cannot vote or provide quorum in Commission meetings, they can undertake all other responsibilities. Comments Submitted to District Agencies

Resolution: DDOT NOI: Advisory Neighborhood Commission 5B passed a Resolution in Support of HAWK Signal Installation at Michigan Ave & Quincy Street NE (NOI 24-84-TESD) and Rhode Island Ave and Thayer Street NE (NOI-24-85-TESD) and sent to the District Department of Transportation (DDOT).

RESOLUTION SUPPORTING AND CALLING FOR KEY ADJUSTMENTS TO WMATA'S 2025 PROPOSED BUS NETWORK: ANC 5B wrote the Washington Metropolitan Area Transit Authority (WMATA) to support the service improvements in WMATA's Proposed 2025 Better Bus Network, especially the D30, D36, P33, C71, C63, D32, and D74; and urges to restore late night service to the proposed D34 as the existing G8 bus runs until 2:00 AM and without it, there will be no bus service after midnight for any location within Commission 5B except for the P40 (T18 bus) running until 2:00 AM on Rhode Island Avenue and 24 hour service provided by the D30 (80 bus), the C61 (H2/H4 bus), and the C41 (B2 bus); and urge to re-add service equivalent to the proposed DC207 line, which would run for the entire length of South Dakota Avenue NE, from Fort Lincoln to Fort Totten.

Resolution in Support of DDOT Moving to the "Design" Phase of the Taylor Street NE and Fort Drive NE Bike Lane Project, Based on the Concept of a Two-Way Protected Bike Lane on the South Side of the Corridor.

Letter in Support of NOI 24-266-TESD: Advisory Neighborhood Commission (ANC) 5B wrote to DDOT to express our conditional support for the proposed safety improvements in NOI# 24-266-TESD in response to the fatal crash which took place on August 28, 2024 near the intersection of Randolph Street and Eastern Avenue NE.

Letter Re: FY2025 Q1 Prioritized TSIs in ANC 5B: ANC 5B wrote to DDOT to express our support for installation of sidewalks, daylighting for intersections, installation of speed humps/bumps/tables where appropriate, and DDOT review the rotational speed camera program.

Issuance of Community Grants

On September 18, 2024 Commission 5B voted unanimously to authorize a grant in the amount of \$1,500 to Friends of Noyes Park for their 2024 Halloween Parade. In accordance with OANC guidance, the funds were issued October 1, 2024, to coincide with the new fiscal year.
