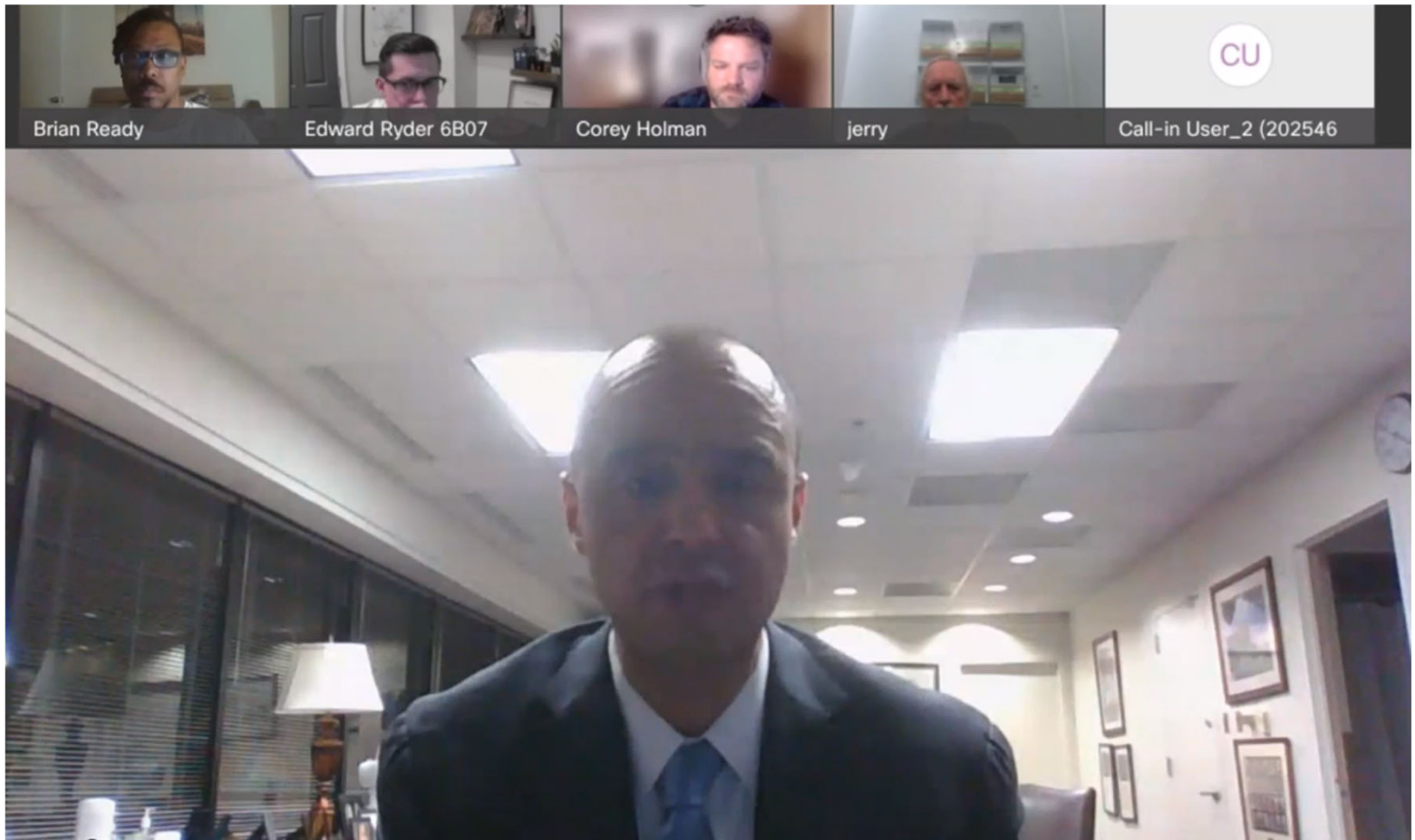

Commission Meetings

- ANC 6B held 11 regular commission meetings and three special call meetings, all via the Webex virtual meeting platform
- ANC 6B started the year with all ten commissioners seated but due to commissioners moving out of the commission area ended the year with eight commissioners. Nonetheless, each commission meeting had a quorum and was able to take official action.
- Meeting attendance by the public varied by topic and guest, but generally was around 30 members of the public attended each meeting. The January special call meeting had over 100 attended and was the maximum attendance at a meeting for ANC 6B in 2022.

- All officers were elected and filled at the January 2022 meeting. The parliamentarian position was vacated in July and was never filled. The Vice Chair position was vacated in October and was filled by Commissioner Samolyk at the November meeting
- All financial documents were approved on time and submitted to relevant agencies

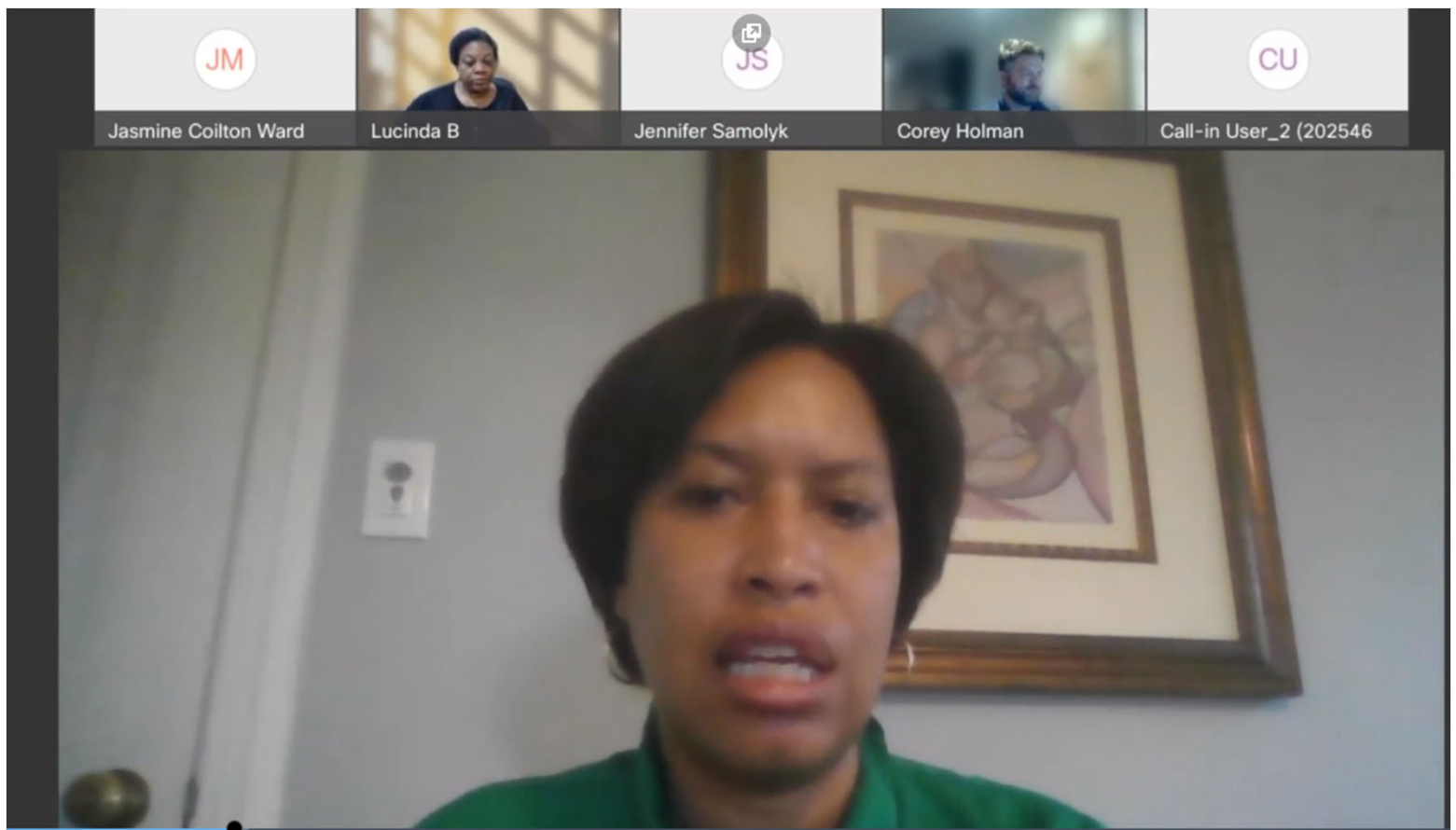
Commission Meeting Highlights

- In March, US Attorney for the District of Columbia visited ANC 6B and engaged in a lively discussion for about an hour



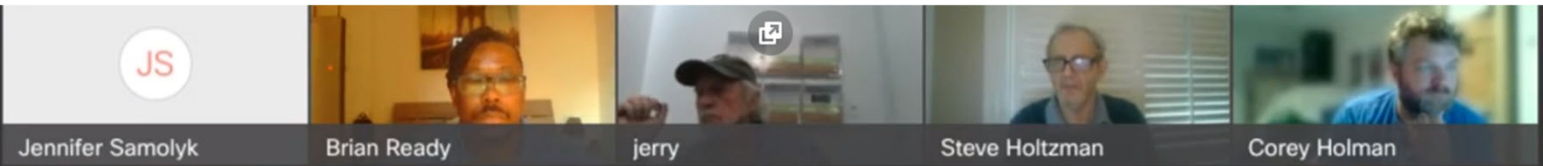
Commission Meeting Highlights

- In May, Councilmember Charles Allen visited ANC 6B to present on the Council's management of the FY23 budget

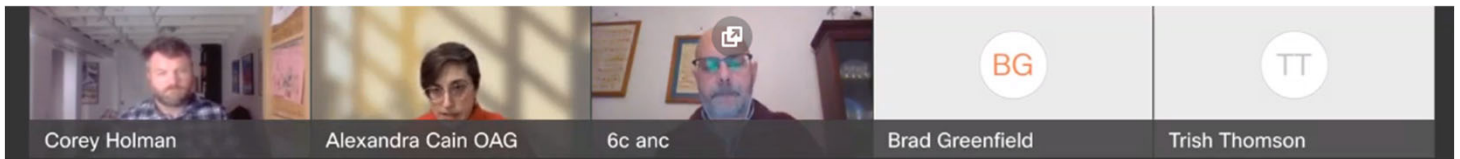


Planning and Zoning Committee

- The Planning and Zoning committee held 11 regular meetings and one special joint meeting of ANC 6A/B/C with the Office of Attorney General. All meetings had a quorum of at least two commissioner and were generally well attended by commissioners and resident members
- The committee considered every business item in time to ensure cases could move forward at the appropriate agency or body without delay caused by ANC 6B
- The committee considered and provided feedback on 17 applications for concept or permit review for alterations to contributing buildings in the Capitol Hill Historic District to the Historic Preservation Review Board. The Committee also considered 2 landmark nominations
- The committee considered and provided feedback on 22 applications to the Board of Zoning adjustment
- In addition to regular work, the committee considered two historic landmark nominations and provided comments on a number of items affecting the community.

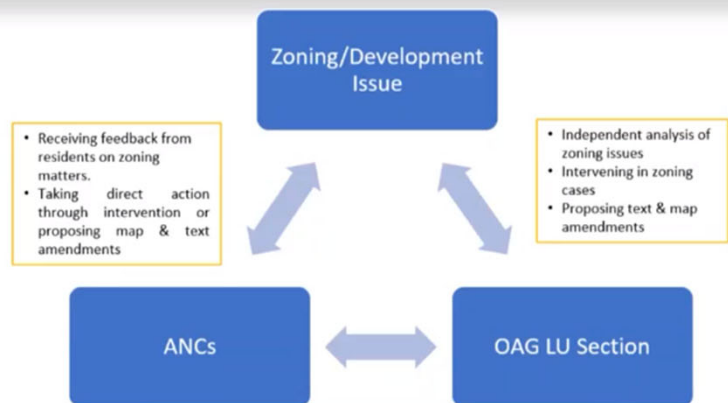
P&Z Committee Meeting with OAG

- In January, ANC 6A, 6B, and 6C's land use committees held a joint meeting with the Office of Attorney General's Land Use Division. The purpose of the meeting was to learn about OAG's new role in land use cases in the District of Columbia and to discuss training opportunities.

- The LU Section will interact with ANCs in two main ways:
 - Training
 - Intervention in cases



Transportation Committee

- The Transportation Committee of ANC 6B met 9 times in 2022 and had a quorum of at least two commissioners for each meeting. In addition, resident members regularly attended and participated in Transportation Committee meetings.
- The committee considered 3 notices of intent in ANC 6B in 2022
- The committee provided feedback on two piece of legislation pending at the DC Council
- The Transportation Committee invited the District Department of Transportation to provide feedback on the following major transportation projects
 - Pennsylvania Ave SE Street Lights, February
 - Pennsylvania Ave SE Mobility Study (bus and bike lanes), April
 - 11th Street exit ramp and corridor study, November

Alcoholic Beverage Control Committee

- The ABC Committee held 8 regular meetings in 2022
- The ABC Committee considered 6 applications for a new license and entered into Settlement Agreements with every applicant.
- The committee considered 3 applications for substantial change and revised settlement agreements as necessary
- The committee considered 30 applications for renewal for restaurant license holders and 11 application for tavern license holders, ensuring compliance with existing settlement agreements and working with the applicants for any changes necessary to existing settlement agreements
- The committee consider four application for a substantial change to an existing license and made adjustment to existing settlement agreements as necessary
- The committee considered two applications for a stipulate license, allowing an applicant to begin operations during the protest period
- In the committee's most vital work, it recommended protest to four application for restaurant license renewals. These protests all ended in new or modified settlement agreements that addressed ongoing issues at each establishment
