## ANC 6C Annual Report 2020

ANC 6C, in order to meet the requirements of Section 1.309-10(n-1) of the Code of the District of Columbia, reports that during the twelve months preceding December 1, 2020, it did the following:

- Held ten public meetings of the commission, six on the WebEx platform;
- Afforded an opportunity at these meeting for brief community announcements from members of the public, government officials, and representatives of various organizations;
- Benefited from the work of commissioners and 6C residents who served on the five 6C committees: Alcoholic Beverage Licensing; Environment, Parks and Events; Grants; Planning, Zoning and Economic Development; and Transportation and Public Space.
- Protested 10 applications for alcoholic beverage licenses or renewals;
- Reached settlement agreements with respect to 5 alcoholic beverage licenses;
- Considered other alcoholic beverage licensing issues, including game of skill endorsements, lack of enforcement of hour of operation requirements, and modifications of existing settlement agreements;
- Submitted recommendations on matters of concern to the Mayor and the Council of the District of Columbia and to agencies and departments of the District of Columbia, including at least 9 to the Mayor or Council; 5 to the Zoning Commission; 5 to the Historic Preservation Review Board; 17 to the Board of Zoning Adjustment; 21 to the District Department of Transportation; and 6 to other District offices;

- Sent correspondence or provided testimony on 8 occasions to federal officials concerning the Union Station Expansion Project;
- Designated commissioners or committee members to represent ANC 6C in at least 31 hearings, meetings or proceedings;
- Awarded grants of \$3000 to the Ward 6 Mutual Aid Network through Save Our City (refurbished computers for students, masks); \$1328.36 to the Capitol Hill Cluster Schools PTA (Peabody) (nature and botany learning materials); \$7500 to Everyone Home DC (connectivity and technology upgrades); \$3500 to the Ludlow Taylor Elementary School PTA (IXL software, City Year volunteers); and \$11,979.60 to the J.O. Wilson Elementary School PTA (distance learning math intervention materials);
- Monitored regularly the development of parks and open spaces in NoMa, as well as the condition and maintenance of parks elsewhere within the ANC 6C area; and
- Posted agendas, minutes and reports of its meetings and committee
  meetings, and copies of its correspondence, as well as information on items
  of interest, on a timely basis, on its website.

ANC 6C in the twelve months preceding December 1, 2020, has been particularly concerned about the impact of the pandemic on the residents of Washington, D.C.; the need for affordable housing in the District; the encampments below the underpasses in NoMa; safety improvements on District roadways for pedestrians and bicyclists; illegal marijuana retail establishments on H Street; draft amendments to the Comprehensive Plan of Washington, D.C.; and the shortcomings of the proposed Union Station expansion project.
