2022 Advisory Neighborhood Commission 7B Annual Report

Advisory Neighborhood Commission 7B herein referred to as ANC 7B or 7B, unanimously voted to file this Annual Report with the Mayor and DC Council and publish the Report on the Commission's website at www.anc7b.com. This Report satisfies the Commission's statutory reporting obligations. For further guidance please see DC Code § 1-309.10(j)(1) (providing that each Commission may file an annual report with the Council and the Mayor for the preceding fiscal year), (n-1) (providing that each Commission shall publish an annual report summarizing its activities over the preceding 12 months).

Advisory Neighborhood Commission 7B (ANC7B or "The Commission") serving the Randall Highlands, Dupont Park, Hillcrest, Fairfax Village, Naylor Gardens, Park Naylor, Twinning, Penn Branch and Fort Davis communities, holds public meetings which are open to every member of the Community to discuss matters impacting the area, share important information, and make policy recommendations to City Officials by way of resolutions and letters of support as needed. The Commission is made up of seven (7) members, each representing about 2,000 residents within their community. ANC 7B's executive meetings are held on the first (1st) Thursday of every month. The public community meetings are held on the third (3rd) Thursday of the month virtually. All public meetings are announced and posted on the official website (www.anc7b.com), Next Door, and sent out via list serves.

In 2022, the Commissioners of ANC 7B participated in the following events in the Community: At the Skyland Town Center, we broke ground at the Lidl Food Market, Ribbon Cutting at the Starbucks, Ribbon Cutting at the Roaming Rooster, Ribbon Cutting

at Lidl Food Market, and the Open House at Edenbridge Pace. Community Walks with MPD in the Randle Highlands and Fairlawn Community to address issued of speeding, loitering, and support of businesses along the lower node of Pennsylvania Avenue, S.E. Site visits at the Shops at Penn-Branch to discuss ideas regarding the residential plan as well as touring other properties to garner ideas for this site. Participated at the Ribbon Cutting and opening of Park 27th Development. Cut the Ribbon at the Randle Highlands' Elementary School Early Learning Center, where we had five out of seven Commissioners present. Commissioners of ANC 7B testified before the Council advocating for issues that affect our Commission, in the areas of Housing and Recreation.

ANC 7B partnered with ANC 8C to host two town halls about issues that affect both Commission area. The first was a DC Water Pipe Replacement Project and the most recent town hall was on Attendance, Chronic Absenteeism, and Truancy in the District.
