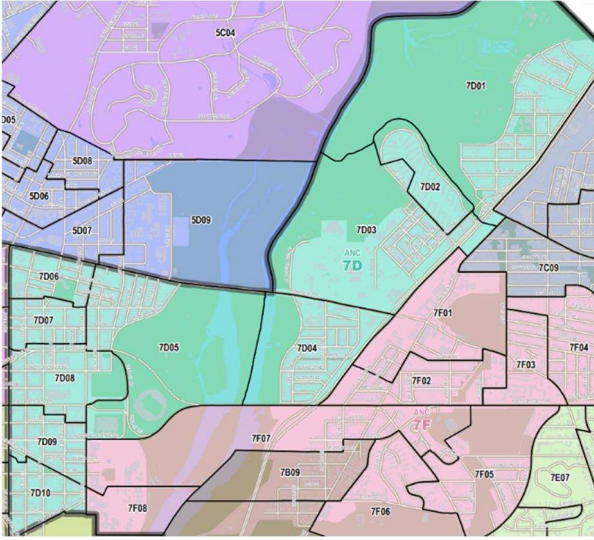


ANC 7D 2023 ANNUAL REPORT



ANC7D is a newly realigned Commission covering Kenilworth, Eastland Gardens, Mayfair, Parkside, River Terrace, Kingman Park, Rosedale, Capitol Hill/Hill East, and the RFK Fields/RFK Stadium Complex and the DC Armory.

The Commission, and its citizen-led committees, consider a wide range of policies and programs affecting the neighborhoods in the Commission area, including transportation, parking, recreation, liquor licenses, public safety, zoning, economic development sanitation and trash collection, and the District's annual budget.

Notable Presentations/Guests:

In 2023, ANC 7D Commissioners hosted a wide variety of District community leaders to provide information and updates of interest to residents in the 7D Commission area.

Mayor Muriel Bowser: The Mayor discussed celebrating a new residential space for seniors. She covered the budget and revitalization of the District will be fueled by public safety and schools. Mayor Bowser discussed how the city has used American Rescue Plan funding and Bipartisan Infrastructure Law funding. There is a \$68 million investment in Hill East to ensure infrastructure is ready. Mayor Bowser highlighted other Ward 7 priorities like the Food Access Fund, a full-service grocery store at East Capitol Gateway, and work at Fletcher Johnson. The budget does not include any tax increases on residents and businesses, and few new programs.

DC Council Chairman Phil Mendelson: Chairman Mendelson discussed his priorities, particularly budget related highlighting school funding and maintaining free bus service as his top priorities. He expanded on housing, congressional interference, the criminal code rewrite.

DC At-Large Councilmember Robert White. Councilmember White spoke about his work on housing, particularly the Emergency Rental Assistance program and efforts to address encampments.

DC At-Large Councilmember Christina Henderson. Councilmember Henderson spoke about her legislative priorities and priorities of the Committee on Health, which she chairs.

DC Department of Transportation (DDOT) Director Everett Lott: Director Lott presented DDOT priority projects covering traffic calming, bicycle lanes and bus services and changes.

DC Public Schools (DCPS) Chancellor Lewis Ferebee. Chancellor Ferebee presented on DCPS achievements and focus for the next year, particularly 8th grade algebra preparedness, reading scores, and college preparedness.

Office of the State Superintendent for Education (OSSE) Dr. Christina Grant. Dr. Grant presented about a range of education issues, including efforts to address pandemic learning loss, youth violence, teacher retention, boundaries, and parental engagement.

Office of DC Attorney General Brian Schwalb. Aaron Jenkins, Director of Community Engagement for the presented on the work of the office.

Andrew Lightman of Capital Community News about efforts to expand the reach of the Hill Rag and East of the River newspapers to more communities in the 7D Commission area.
