October 9, 2024 REGULAR MEETING OF THE COMMISSION

CALL TO ORDER

The meeting was held at the Latin American Youth Center (1419 Columbia Rd NW) and virtually via Zoom. Commissioner Dieter Lehmann Morales called the meeting to order at 7:05 PM. R24-0020, A Resolution Concerning a Resolution Concerning the Root Causes of and Response to the Gas Explosion at 1433 Columbia Rd NW (Perri, Lehmann Morales, and Thomas-Daivs)


- Motion in support of A24-0007 was approved by voice vote, 9 Commissioners voting "Yes"; 0 voting "No"; 0 Abstaining.
