# Call to Order

The regular October 2024 meeting of the Dupont Circle Advisory Neighborhood Commission (Commission of ANC 2B) was called to order by Chair Roggensack at 7:02 pm.

#### Alcoholic Beverage and Cannabis Board Agenda:

#### Onggi- Application for a Retailer's Class "C" Restaurant License at 2100 P Street, NW (ABRA-130563)

Chair Roggensack moved to adopt the resolution. Commissioner Johnson seconded the motion, which was voted on and passed (VOTES: 6-1-0). The resolution reads as follows:

WHEREAS, Peona Korean Dining, LLC t/a Onggi ("Onggi") has applied for a new Class "C" Restaurant Alcoholic Beverage license (ABRA-130563) at 2100 P Street NW, located in ANC 2B, Single Member District 2B02;

WHEREAS, Onggi's placard states the establishment has inside seating capacity for 70 persons and total occupancy of 110 persons;

WHEREAS, Onggi's application requests endorsement for Alcohol Carry-Out and Delivery.

WHEREAS, Onggi's placard hours are as follows:

Hours of Operation

Alcoholic Beverage Sales, Service, and Consumption inside the premises and the sidewalk cafe

Sunday through Thursday– 8:00 AM – 2:00 AM

Friday and Saturday– 8:00 AM – 3:00 AM

Alcoholic Beverage Carry-Out and Delivery

Sunday through Saturday - 8:00 AM - 1:00 AM

WHEREAS, ANC 2B welcomes an establishment with late night serving hours.

WHEREAS, promoting and maintaining good relationships between residents and nightlife establishments is a responsibility and priority of ANC 2B.

WHEREAS, ANC 2B's established guidelines specify unenclosed café hours near residences as ending at 11:00 PM Sundays through Thursday, and 12:00 AM Midnight on Fridays and Saturdays.

WHEREAS, the establishment's space at 2100 P Street NW has an atypical configuration of its sidewalk café – part being enclosed and part unenclosed.

WHEREAS, ANC 2B had settlement agreements with previous ABCA-licensed establishments at the location establishing *enclosed* sidewalk café hours as concurrent with inside service hours, and

the *unenclosed* hours as ending at 11:00 PM Sundays through Thursdays and 12:00 AM Midnight on Fridays and Saturdays.

THEREFORE BE IT RESOLVED that ANC 2B supports Onggi's application, subject to the Establishment executing a Settlement Agreement with ANC 2B, establishing the closing time of the *unenclosed* sidewalk café space as 11:00 PM Sundays through Thursdays, and 12:00 AM Midnight on Fridays and Saturdays.

BE IT FURTHER RESOLVED that ANC 2B will file a pro forma protest of the application on the basis of Peace, Order, and Quiet, which will be withdrawn upon approval of the Settlement Agreement and Order by the Alcoholic Beverage and Cannabis Board.
