# Advisory Neighborhood Commission 6E Virtual Public Meeting Tuesday, December 17, 2024

# 1. CALL TO ORDER AND ROLL CALL

## 2. APPROVAL OF AGENDA

#### 3. APPROVAL OF NOVEMBER 2024 MINUTES

### 4. UPDATES FROM WARD 6 COUNCILMEMBER ALLEN'S OFFICE Erik Salmi, Deputy Chief of Staff

Erik Salmi provided updates from Councilmember Allen's Office relating to: the final deal regarding Capital One Arena, the Fraudulent Vehicle Tag and Parking Enforcement Modernization Amendment Act of 2024, the Carrier-For-Hire Oversight and Enforcement Act of 2024, the PLAZA Act (Public Life and Activity Zones Amendment Act), and the confirmation of a new permanent Director of the Office of Neighborhood Safety and Engagement (ONSE). Marcus Manning provided updates from the Mayor's Office relating to the Fresh Start 5K Race on January 1, 2025, the Shelter Hotline (202-399-7093), the National Building Museum's holiday free skating period, the DMPED's DC Venture Capital Program, and a process protocols meeting regarding the Inauguration. ## 8. NEW CLASS "D" STIPULATED LIQUOR LICENSE: GOOD COMPANY DOUGHNUTS AND CAFÉ, 555 PENNSYLVANIA AVENUE NW (SMD 6E08) Cameron Mixon

**MOTION:** The Commission AGREED (5 yeas - 0 nays – 0 abstentions) to SUPPORT the new Class "D" Stipulated Liquor License Application for Good Company Doughnuts and Café, 555 Pennsylvania Avenue NW, and to convey that support to ABCA. (Motion by Commissioner Prince, Second by Commissioner Forest).

#### 9. NEW STIPULATED LIQUOR LICENSE APPLICATION: JOBSITE HOSPITALITY, LLC, 101 CONSTITUTION AVENUE (SMD 6E08) Cindy Block

**MOTION:** The Commission AGREED (5 yeas - 0 nays – 0 abstentions) to SUPPORT the new Stipulated Liquor License Application for Jobsite Hospitality, LLC, 101 Constitution Avenue NW, and to convey that support to ABCA. (Motion by Commissioner Prince, Second by Commissioner Forest).

#### 10. UPDATE TO GEORGETOWN UNIVERSITY PROPOSED CAPITOL CAMPUS WAYFINDING PLAN (SMD 6E07, SMD 6E08) Cory Peterson

**MOTION:** The Commission AGREED (5 yeas - 0 nays – 0 abstentions) to SUPPORT the modifications to the Georgetown University Capitol Campus Wayfinding Plan and to convey that support to the Public Space Committee. (Motion by Commissioner Hart, Second by Commissioner Prince).

# 11. MOUNT VERNON TRIANGLE CID: 600 K STREET NW ALLEY – CONFLICTS AND PROPOSED INTERVENTIONS

**MOTION:** The Commission AGREED (5 yeas - 0 nays – 0 abstentions) to SUPPORT the Mount Vernon Triangle Community Improvement District's plan to implement modifications to the alley on the north side of K Street NW to address parking and traffic concerns. (Motion by Commissioner Hart, Second by Commissioner Hans).

**MOTION:** The Commission AGREED (5 yeas - 0 nays – 0 abstentions) to express SUPPORT for examining the appropriate parking solution for the 600 block of K Street NW but that the ANC requests additional information on the appropriate solution to possibly include commercial loading zones or 10-minute parking zones before offering an official endorsement. (Motion by Commissioner Hart, Second by Commissioner Forest).
