- Commissioner Berry stated the Transportation and Public Space Committee met this
  past Wednesday. Residents should check the website and look for the notices and are

- Ankit Jain introduced himself and stated he is one of two recently elected Shadow Senators. Shadow Senators are elected advocates to the U. S. Senate fighting for DC Statehood and protecting our Home Rule from attack. Their focus deals with issues related to the Federal Government and are resources residents can reach out to if needed. They are in the process of writing their 2025 Budget and if residents have ideas on projects that promote DC Statehood, please email them to him. - 6. DDOT NOTICE OF INTENT 24-294: QUICK BUILD SAFETY IMPROVEMENTS TO INTERSECTION OF 7<sup>TH</sup> AND Q STREETS NW [2G02 AND 2G03] Christophe Wassmer, DDOT

**MOTION:** Commissioner Padro moved and Commissioner McCarty seconded that ANC 2G *support* the implementation of DDOT Notice of Intent 24-294: Quick Build Safety Improvements to Intersection of 7<sup>th</sup> and Q Streets NW, with the stipulations that the bus stop at the southwest corner of 7<sup>th</sup> and Q Streets NW be converted into a Commercial Loading Zone <u>and</u> that a more comprehensive traffic study be implemented for the intersection of 7<sup>th</sup> and Q Streets NW, with the objective of maximizing pedestrian, bicyclist and driver safety, and that this recommendation be submitted to the Director of the District Department of Transportation (DDOT). The Motion **passed** 5 yeas – 1 nay (Commissioner Berry) – 0 abstentions.

New items added to the project will require further submissions to DOB and DDOT, and engagement with the engineering firm to update the contract drawings and obtain the new or any revised permits needed, again resulting from the BZA added scope. They are also engaging with the general contractor, Keystone. They will be remobilizing at the job site, and that will be over the next 2 to 3 weeks. They will also be tasked to provide a revised project delivery schedule. The project delivery schedule will reflect again the new changes and new scope that was added, plus the new time to get the permitting done. This probably will take about 4 to 5 weeks to get completed.
