## **Regular Public Meeting Minutes**

Monday, January 27, 2025, 7:00 p.m.

#### Call to Order & Roll Call.

The meeting was called to order at 7:02 p.m. by Commissioner Tiffani Nichole Johnson and roll call was conducted by ANC Executive Director Kent Boese. ### 2. Administrative Items

#### a. Officer Elections
