A. DDOT TSI 2.0 Demo, Kornelius Anderson (10 mins)

- Used to be a first-come first-served system; now, intended to be equitybased and data-driven. 200 locations city-wide will be selected per quarter to be studied. Intent is for implementation/installation to take place in the following 1-2 quarters.
- DDOT maintains a TSI Dashboard on their website to track TSIs planned for each quarter and the final decision.
