  - a. Friends of MBT Grant Application
    - Purpose and benefits to the community: Deploy materials and supplies for drinking water stations along the MBT.
      - Working with Eckington Parks and Arts, they will supply dog waste bags. There is a need to respond and provide water to the Bryant St Dog Park, and by Carlos Rosario. The Bryant Street Dog Park does not have this community benefit, whereas other dog parks (Eckington Dog Park) do. The Friends of MBT would like to deploy stations by 4/19. The grant funding includes materials for volunteer kits (drawstring bags, sticky notes, Sharpies).
      - Commissioner Bishop Henchman requests to suspend rules so that we can have time to approve the grant. Commissioners all agreed when the agenda was approved
    - Questions
      - Commissioner Williams: Request to postpone the vote until she meets with Bryant Street Management representatives. Mr. Chauffin mentioned he'd asked, and the Bryant Street Management representatives will not add drinking fountains to this area or allow their workers to manage this. Commissioner Bishop-Henchman added additional context, encouraging the ANC to continue our voting today because of the timeline, we may not see any of the Bryant St management requests by this Summer. Commissioner Williams agreed to vote today and keep everyone updated on any updates from the Bryant Street Management representatives.
      - Neighbor: Environmental exposure in the dog waste bags and water cups? Friends of MBT shared that they are environmentally conscious and that the supplies will help remove dog waste along the trail, and the cups are eco-friendly.
