ANC 5E Public Meeting Minutes (February 2025) Tuesday, February 18, 2025

Present: Commissioners Kyle Gardiner, Karla M. Lewis, Michael Bloomberg, Huma Imtiaz, Alice Arcenia Thompson, Kirby Vining.

1. Commissioner Imtiaz provided instructions for public participation in the meeting.
2. The meeting was held in virtually via Zoom and began at 7 p.m. ET with a quorum with 6 Commissioners present.
3. Commissioner Bloomberg motioned to approve the consent calendar with January 21, 2025 meeting minutes as well as revisions to the Grant Guidelines, Committee Guidelines, Procedures and Guidelines. Commissioner Vining seconded the motion.
 - a. Motion to approve the consent calendar items passed via voice vote with a 6-0-0 vote: Commissioner Gardiner (Y), Commissioner Lewis (Y), Commissioner Bloomberg (Y), Commissioner Imtiaz (Y), Commissioner Thompson (Y), Commissioner Vining (Y).
4. Commissioner Vining presented the bills and reimbursements.
 - a. A check for \$483.48 was issued to the Stronghold Civic Association for reimbursement of a community clean-up/beautification event.
 - b. A bank fee for \$216.49 for new checks was refunded because misprinted. Corrections were made to the checks (two signature lines, proper check numbering, and duplicate pages for the checks) and the new adjusted fee for the correctly printed checks was \$322.16, debited from the ANC 5E account.
 - c. Commissioner Vining explained how a reimbursement for incorrectly issued checks had resulted in a \$438.65 deficit in our FY25 budget when the bank charged for the new, correct checks. The deficit in the budget is more than the final cost of the checks because the account was debited twice – first for \$216.49 and then for \$322.16, total \$538.65. There was \$100 in that budget line item so $\$538.65 - \$100 = 438.65$, the line item that must be “cured.”
 - d. Commissioner Vining discussed the need to move \$500 of the ANC 5E budget’s “other” line to the “bank fees” line to cure the bank fee for newly issued ANC 5E checks. The treasurer moved the process to “cure” the budget deficit: MOVED that the treasurer is instructed to move \$500 from the “Other” line of the ANC 5E budget to the “Bank Fees” line of the budget to cure the unanticipated payment for new ANC5E checks.”
 - e. Commissioner Imtiaz motioned to cure the ANC 5E budget as recommended

- a. Commissioner Gardiner discussed a new monthly Dunbar HS-McKinley Tech HS bike bus which is run by Alex Clark, the Physical Education teacher at Dunbar HS. The next one is planned for Wednesday morning, February 26. Details for community participation may be presented at the March ANC 5E meeting.
- b. Commissioner Lewis discussed the ongoing Community Needs Health Assessment from Howard University Hospital and Sibley Memorial Hospital, which can be completed [here](#) before February 21; the recently announced DDOT Notice of Intent for roadway changes related to the Better Bus Network plan; and that Commander Pulliam of the Third District would not be in attendance tonight due to unexpected conflicts.
- c. Commissioner Bloomberg discussed program updates to the Food Waste Smart Bin program, including the recent installation of a Smart Bin outside of Big Bear Cafe.
- d. Commissioner Thompson discussed concerns related to recent gun violence in SMD 5E05; leaks related to the crack at the McMillan Reservoir retaining wall on First Street; and concerns about alleyway damage along 77 and 79 Bryant St. Due to nearby construction
