The June meeting will include a discussion of the proposed B26-058, Recycling Refund and Litter Reduction Amendment Act. Under that plan, consumers would pay a 10-cent deposit on eligible beverage containers (plastic bottles, glass bottles, or aluminum cans) at the point of purchase and get a refund when they return the containers to a designated recycling center in a store or a reverse vending machine.

MPD Community Report

Discussion of DC Proposed Budget for FY 2026 (October 1, 2025-September 30, 2026)

The Mayor's proposed FY 2026 budget was not delivered to the DC Council on April 2 as originally scheduled because of the uncertainty over the funds that will be available to the District in FY 2025. As a result the Council budget hearings that were expected to start in April will be rescheduled in May and June. The ANC has asked for speakers on the budget from the Mayor's office and the Council. There are expected to be opportunities for oral testimony and written comments on the level of funding for all program areas in the proposed DC budget, working toward the final Council votes on the FY 2026 budget by July.

Presentation on "RiverSmart Homes" Program to help reduce stormwater run-off at DC residences RiverSmart Homes can help with installing features such as rain barrels, trees, and native plant gardens and removing hard surfaces on the property. The program is offered to residential properties in the District including single family homes, duplexes, and multi-family homes with up to four units. DDOT proposal for buses to turn left from eastbound Massachusetts onto Wisconsin during peak hours On April 28, DDOT issued a Notification of Intent NOI #25-123-CPD that proposes to add "Except Buses" to the existing sign "No Left Turn 7-9:30 AM 4-6:30 PM Monday-Friday" from Massachusetts Avenue onto northbound Wisconsin Avenue. The proposed change would allow operation of the new "C85" weekday Metrobus route that will run every 30 minutes during peak hours (5 buses in the morning, 5 buses in the afternoon) between upper Chevy Chase, Jackson-Reed High School, Tenleytown Metro, Wisconsin Avenue through ANC 3A, Cathedral Avenue, New Mexico Avenue, Glover Park, Reservoir Road, MacArthur High School, MacArthur Boulevard, Canal Road, and Foggy Bottom. The proposal will give further support to WMATA's "Better Bus" network that will go into effect on June 29, 2025. Comments must be filed in writing by June 10, 2025, with the District Department of Transportation, Transportation Delivery Division, 250 M Street, S.E. Washington, D.C. 20003, or by email to ddot@dc.gov with the subject line "ANC 3A NOI# 25-123-CPD (WMATA Better Bus)." Commissioner Updates

- <u>Proposed Bus Stop on 39th Street</u>: DDOT has accepted the recommendations of ANC 3A and numerous residents and will not go ahead with its proposal in Notice of Intent NOI# 25-27-CPD to install a new bus stop on 39th Street NW just south of Klingle Place NW, on the planned D96 Metrobus (part of the Better Bus network). The proposed bus stop would have created safety risks and eliminated all the curbside parking and loading/unloading spaces serving the private home at that location. On April 30, DDOT expressed by letter to ANC 3A writing that it will not install the proposed bus stop on 39th Street (or other part of 39th Street).

- Better Bus Network: WMATA will be introducing a system-wide reconfiguration of bus routes, numbers, route maps and schedules for all Metrobus services on June 29 as part of the "Better Bus" redesign approved by the WMATA Board in November 2024. This will include changes to the Metrobus routes serving Wisconsin Avenue, Porter Street, Massachusetts Avenue, Cathedral Avenue, Nebraska Avenue, Woodley Road, and other local corridors. 
