

### THE MINUTES OF THE

### May 21, 2025 REGULAR MEETING OF THE COMMISSION

#### Call to Order

The meeting was held virtually via Zoom. Commissioner Jeremy Sherman called the meeting to order at 7:10 PM. In accordance with D.C. Official Code §§ 1–207.42 and 1–309.11(c) the meeting was properly noticed in advance and open to the public.

### **Roll Call & Determination of Quorum**

Commissioner Billy Easley, serving as Secretary, proceeded with the roll call

Motion to approve the Agenda was seconded by Commissioner Perri and was **approved 8-1** with Commissioner Thomas-Davis opposed due to concerns about waiving the rules about grant spending.

Motion to approve the April minutes was seconded by Commissioner Lehmann Morales. The minutes were approved unanimously.

**Secretary Report:** Commissioner Easley noted that the Department of Public Works had still not responded to two resolutions passed by the Commission in February in March regarding the reinstallation of trash cans in his SMD and that he would follow up on them.

**Treasurer Report:** We ended Q2 with a positive balance of \$51,442 and 49 cents.

**Commissioner Announcements:** Commissioner Knoll announced his resignation from the Commission due to moving out of his SMD. Commissioner Achenbach introduced himself to the community as this was his first official meeting as a member of the ANC. Commissioner Davidson announced that the Commission will be passing out native sunflower seeds at the Saturday farmers market in an effort to beautify Columbia Heights.

**Public Announcements:** A resident discussed their concerns about crime in the area, MPD's response, and the rate of business closures in the area. Commissioner Easley spoke to him about the Public Safety Committee and invited him to join. Commissioner Thomas-Davis also responded to his concerns.

Estelle Mckinney, from Councilmember Nadeau's office: MPD is adding more CCTV cameras on Sherman Avenue and spoke about criminal incidents around Fairmont Street, Commissioner Davidson is working with her to set up a response and community meetings. Inner City Cooperative will be at the Columbia Heights metro next Wednesday to work with the OAG to help provide resources and outreach to the community. CM Nadeau is working on legislation requiring only staircase instead of two in buildings of a certain size to make it ease the building construction process.

Anthony Robertson, Mayor's Office of Community Relations and Services: Responded to our residents concerns about crime in the area and invited him to join the local MPD community walks that are being planned. He also urged residents to utilize 311 to notify government agencies of issues.

#### **Presentations:**

(a) **Nicole McEntee**, *Education and Outreach Program Analyst*, Office of the Tenant Advocate

- Discussed OTA's outreach to renters. They are working very hard to develop tenant associations in the District. This is Mrs. McEntee's primary work at the moment.
- Commissioner Easley asked about their outreach strategy. Mrs. McEntee stated that they will be trying to do a Tenant Summit which will be a district wide resource fair his year but there are budget concerns – they are aiming for September.
- Commissioner Sherman asked about noise from neighboring properties and whether OTA can assist tenants navigate that issue? Mrs. McEntee said it's tricky when it's not noise that the landlord is causing or could prevent.
- Commissioner Davidson asked about outreach in other languages. Mrs. McEntee has a counterpart who is a fluent Spanish speaker so she will attend when she goes to other events. They also have two other people who are fluent Spanish speakers and they will use the language translation phone line if necessary.
- (b) **LaToya Davenport**, *Community Outreach Specialist*, Office of the United States Attorney for the District of Columbia
  - Discussed resources provided by USAO. Discussed the new CCTV cameras being placed in the area to assist crimefighting efforts. They will be hosting the 15<sup>th</sup> Annual Youth Summit at Catholic University focused on Tuesday, July 8th. The topic this year will be gun violence and drug prevention. There will also be a Resource Fair at the Columbia Height Metro and DYRS, MPD, Credible Messengers, Mayors Office, will be in attendance. That will be on Wednesday, May 28<sup>th</sup> at the Metro.
- (c) Adam Carballo, AIA, Principal, Carballo Architecture
  - Asked the ANC to support rezoning a parcel of land at 1327 Girard NW, located in 1A09. Commissioner Knoll, who represents this area, supports the rezoning.

**Committee Reports:** Commissioner Thomas-Davis shared the report of the Permanent Special Committee on Public Life and Neighborhood Planning concerning Case No. 25-06 from the District of Columbia Historic Preservation Board (HPRB) and noted that the Committee supported the historic designation.

Commissioner Thomas-Davis made a motion that the Commission adopt the report of his Committee. Commissioner Knoll seconded the motion. It was approved by voice vote unanimously and **approved.** 

All other reports were placed at the bottom of the April agenda for review.
