MINUTES

- I. Call meeting to order: 6:50 p.m.
- II. Quorum: Present: 5A02-Thomas, 5A04-Hermes, 5A03-Lucio, and 5A09-Bocoum 5A03-Lucio had to leave early. 5A08-Alston and 5A06-Holloway arrived late
- III. Introduction of new Commissioner for 5A04 Jack Hermes. Welcome!
- IV. Agenda Review/Acceptance: Motion to accept agenda Bocoum, second Thomas. Motion passed.
- V. Commission Business
 - A. Minutes (February 2025): Motion to approve minutes Bocoum, second Thomas. Motion passed.
 - B. Treasurer's report. March monthly Treasurer's report emailed to commissioners. Balance is still \$103,095.69. No transactions in the past month. Motion to accept Treasurer's report Thomas, second Hermes. Motion passed.
 - C. We plan to pay for our Zoom account and Post Office Box. Will be reported on next month.
 - D. Request by Commissioner Alston for a laptop and phone. We have the money in our budget. Request tabled until next executive meeting.
- VI. Commission Action Items & Updates
 - A. 5A09 Social Justice School, currently located in temporary classrooms next to Fort Totten Metro Station, is planning to build out a vacant warehouse as their permanent location. They requested a letter of support: Bocoum moved that ANC 5A write a letter of support for SJS. Seconded by Alston. Motion passed.
 - B. McDonald's Construction Update: Restaurant has closed down. Demolition scheduled to start in April. Still on schedule to complete construction by Labor Day weekend. One lane of Delafield will be temporarily closed. Rat abatement treatment took place in the area, including on the hillside and behind the strip mall between the McDonald's and the church.

 - Mayor Bowser will present her budget to the DC Council on April 2. Concern about possible \$1 billion cut. This issue may or may not be resolved by then. Further discussions will take place in April and May.
 - 2. Office of the Clean City would like to announce that any DC resident can organize a community cleanup. They will provide rakes, gloves & pickers.
 - 3. Street sweeping is in effect. There are fines for not moving your car.
 - 4. MySchoolDC Lottery results will be announced on March 28.
 - 5. Community concerned about broken slide at NMP Rec Center playground. Requests to 311 to have this repaired have been submitted dozens of times over the past year.

- B. Councilmember Zachary Parker's office. Oliver Stoute, Constituent Services Director <u>ostoute@dccouncil.gov</u> and Andrianna Lovelance, newly hired Constituent Services Coordinator: <u>alovelace@dccouncil.gov</u>
 - 1. Concern about possible \$1 billion DC budget cut. Councilmember Parker joined Mayor Bowser and CFO and Council colleagues at a press conference calling on the U.S. House of Representatives to pass a bill already passed by the U.S. Senate to restore DC's right to spend our own money as passed in our FY2025 budget.

- 4. Providence Hospital redevelopment is moving forward. Townhomes and retail will replace the main hospital; however, the OAG has secured a favorable deal including \$5 million to support health care in DC. - B. Cmr Alston mentioned that Z Burger is increasing their hours, including serving breakfast, and offering a 15% discount to 5A residents upon request.
- C. Cmr Alston will check with the medical marijuana establishment to find out if they are still planning on opening their business next to the McDonald's on South Dakota Ave.
- D. Cmr Alston and Cmr Holloway will plan block parties this spring or summer.
- E. Cmr Alston would like to see more programs for senior citizens, such as a community orchestra.
- F. Bill Smith requested more SMD meetings and to make sure they are posted on the website.
