# Resolution Regarding NPS Rock Creek and Potomac Parkway Multimodal Safety and Operational Improvements Plan/Environmental Assessment- 8:02 pm

Commissioner Lohse moved to adopt a proposed resolution regarding the matter. Commissioner Maysak seconded the motion, which was voted on and passed (VOTES: 7-0-1). The resolution reads as follows:

The National Park Service (NPS) issued a 30-day public comment period (April 2 – May 2, extended to May 17th) for its proposed Rock Creek and Potomac Parkway Multimodal Safety and Operational Improvements Plan. Thousands of people use the Parkway every day. Given the Parkway's important role in vehicle, pedestrian, and multimodal transportation in Washington, DC, plus the many other related transportation projects underway by our city's transportation department (DDOT), ANC 2E found this to be a short comment period. Our community loves Rock Creek Park and supports NPS safety efforts; however, we also know the Parkway must play a key role in our city's transportation network.

*Context for Georgetown.* Georgetown is the 2nd most visited destination in DC and serves as a connector to many parts of DC, VA, and MD. We reviewed this proposal with the following context:

- Most of ANC 2E's main roads connecting Georgetown to the immediate neighborhoods to our east (West End and Dupont) plus downtown have a direct connector on/off Rock Creek Parkway.
- Georgetown has no metro stops, and neither do the DC neighborhoods to our immediate West and North.
- In the last few months, several of our WMATA bus routes were cut on the East-West roads (O, Dumbarton, P) that connect Georgetown to the neighborhoods to our east, and to downtown
- Four months ago, the Circulator to downtown via Georgetown was also cut.
- Our community is in the process of urging DDOT that safety efforts on residential roads must be prioritized /funded as we work with the city on how best to aim to transform the usage of the main arterials for non-transportation purposes (e.g., streateries) given spill-over traffic from these main arterial efforts impacts our side residential streets.
- We are aware that Dupont is also undergoing a major transformation of its main road (Deckover project on Connecticut Ave); it is unclear how this may impact traffic into Georgetown.
- We have the 2nd highest number of multi-module trips (scooters, bikes) next to the National Mall (300,000 in 2023); we are pushing to ensure pedestrian safety is considered key to this growing multi module usage and related parking needs.
- Like other DC residents, many of our constituents work for the Federal government. Those who are employed as such are now required to work in the office on a full-time basis; how they get to work and back from work is evolving.

In all the above transformative discussions, the scarcity of resources is brought up as a key factor when we work with DDOT, the Council and the other agencies on implementation options. We want to ensure resources are available for safety for all, including our neighborhood.

**Support**. ANC 2E is supportive of the overwhelming number of safety efforts proposed by NPS, including the much-needed expansion of the multi-module trail. We want to call out our support including for: the proposed new intersections, the proposed signal changes, the proposed new medians, and the proposed new left-hand turns.

Non Support. At this time, we are not supportive of the removal of the reversible rush hour lanes given the NPS analysis and resource planning regarding the impact to the local roads and neighborhood immediately connected to Rock Creek Parkway – including Georgetown - is not amply outlined. Our concerns include a lack of consideration for the interconnected aspects of transportation efforts going on throughout DC currently and the lack of resources available/planned for ensuring safety for our impacted neighborhoods. Our neighborhoods may or may not ultimately serve as an alternative to Rock Creek for many commuters. Our constituents have asked for a specific review of how the proposals to change signals and the addition of new intersections will ensure commuter traffic isn't pushed into Georgetown, where there are several on/off ramps to Rock Creek. There also is a specific concern for non-arterial roads given M and Wisconsin (arterials) have other efforts occurring.

Separately, We also want to ensure our constituents who need to get to work downtown can, so closing off ramps like the P Street Ramp is a questionable option given the contextual issues outlined above such as bus cuts.

The ANC 2E Commissioners representing the East Side of Georgetown (side that connects to the Parkway) had a call with NPS staff/study experts and requested to speak with those who conducted the analysis. We asked to work through Georgetown-specific traffic routing and potential additional local safety measures including on immediate adjacent District land; efforts that DDOT would likely need to fund, not NPS. NPS agreed to do so, and we are following up with NPS, but time does not allow for that dialog before this comment period ends.

Asks- Automation and Technology. We fully appreciate the risk to NPS/MPD team members to manually place wooden barriers up each day for rush hour; NPS staff should not be at-risk. We ask NPS to consider outlining the cost of how technology can be applied to support the reservable lanes (e.g. signage, non-manual gates on on/off ramps). Such methods would be useful no matter what given city-wide events that call for the full closure of the Park do occur, and such events may get more frequent as our city becomes greener.

In sum, per our dialog with NPS team, we request (1) the above technology analysis, (2) direct access to study experts that can demonstrate traffic pattern changes to Georgetown, with volumes, and how NPS is ensuring the multitude of vehicles that could use Georgetown for commuting needs if Rock Creek is too congested will not do so, and, (3) that NPS has DDOT commitment that city budget allocations are being made and experts applied to safeguard our local neighborhoods roads, and thus pedestrians, bikers, and others. We look forward to collaborating with NPS on this request.

### Resolution Regarding Support for Rose Park Farmers Market- 8:15 pm

Commissioner Lohse moved to adopt a proposed resolution regarding the matter. Commissioner Maysak seconded the motion, which was voted on and passed (VOTES: 8-0-0). The resolution reads as follows:

ANC 2E supports the Friends of Rose Park's application to stage the 2025 Rose Park Farmers Market in Rose Park, located at 2609 Dumbarton Street NW, every Wednesday from May 7, 2025 to October 29, 2025 from 3pm-7pm. The market serves as a wonderful community-based gathering spot, while also providing residents with a place to shop for locally grown produce, buy pre-prepared food, purchase items from small local businesses, and enjoy special events like holiday celebrations and pup parades. ANC 2E fully supports this fantastic community building effort.

ANC 2E asked that these Washington Gas boxes/towers located go to OGB for review and some level of effort is made by Washington Gas to make the towers more aesthetically pleasing given they are located in a historic district. Commissioner Lohse moved to adopt a proposed resolution regarding the matter. Commissioner Chao seconded the motion, which was voted on and passed (VOTES: 7-0-0). The resolution reads as follows:

The building was constructed in 1909 by a florist who lived in the neighborhood. It has operated as a flower shop or salon for most of its 116-year history. This application proposes to add a second floor on top of the square footage of the existing building, which means several at-risk windows of the immediate property will be covered. The building was recently renovated with OGB-approval in 2020. ANC 2E was told by the owner at that time:

- The city informed the owner that any 2nd floor addition must adhere to a street facing set-back.
- The CFA/OGB required the street facing facade be restored to as close as possible as the original structure, which was done by removing the old bay window and adding back in the transom windows (see Attachment A of the original property from 1908).

At this time, ANC 2E does not support this application; the applicant has not spoken with the impacted neighbor immediately to the North about the applications. The neighbor would have a loss of light on its south facing wall. A dialog needs to occur among the parties. With regard to the proposed façade changes in the application and the massing, ANC 2E looks to the Old Georgetown Board to determine if the new façade and massing speak to earlier OGB guidance on this historic property.
