Welcome & Reports (7:08 PM)

Call to Order & Roll Call

Adoption of the Agenda

Treasurer's Monthly Report

Comm. McCray reported that the OANC notified her that there was a typo in the approved February 2025 public meeting minutes. The typo has been fixed. For May, ANC 5D's beginning balance was \$51,337.78. The ending balance was \$57,000.86. There were no expenditures, and the OANC allotment of \$5,663.08 was received. For June, the beginning balance was \$57,000.86, and the balance as of the meeting was \$56,122.32. This amount will have changed by the end of the month due to additional expenditures.

Commissioner Reports

Comm. Arbuckle (5D01 – Union Market): Nothing to report.

Comm. Rhodes (5D02 – Ivy City): Comm. Rhodes shared that Workshop #3 for the Ivy City Resilience Strategy Plan will be in Lewis Crowe Park on Saturday, June 14, 3 PM - 5 PM.

Comm. Roblin (5D03 – southern Trinidad): Comm. Roblin shared that she is working on improving lighting in several areas in the neighborhood. She and Comm. McCray are also working with MPD regarding safety issues at Neal and Staples. The Trash and Beautification Committee will be having cleanups every first Sunday of the month, leaving from the Trinidad Farmers Market, from 9:30 AM - 11 AM.

Comm. Hosler (5D04 – central Trinidad): Comm. Hosler is still getting onboarded. He has lived in the neighborhood since 2012. He is looking forward to connecting more with this community.

Comm. Sauceda-Guzman (5D05 – northern Trinidad): Comm. Sauceda-Guzman shared that their single member district (SMD) 5D05 has been dealing with a lot of gun violence lately. The commissioner is working to develop a youth mentoring program, as well as planning for upcoming events including Trinidad Day.

Comm. McCray (5D06 – parts of Trinidad & Carver-Langston): Comm. McCray shared that the Health and Wellness Community Day at the end of May was successful despite the rain. There will be a Transportation Committee meeting on Wednesday, June 18, with discussion of the recent changes to 17th St NE.

Comm. McCullum (5D07 – parts of Trinidad & Carver-Langston): Comm. McCullum shared that there has been a dangerous situation at 1835 H St. NE; there will be a press conference on June 24 at 11:20 AM.

Comm. Holsendorf (5D08 - northern Carver-Langston): Absent.

Comm. Green-Campbell (5D09 - eastern Carver-Langston): Nothing to report.

Public Safety Report

As the representative from the MPD 5th District was not present, the ANC went to the next item.

Executive Office of the Mayor

Brian Hanlon, Director of the DC Department of Buildings, presented on GROW DC, the Mayor's proposed FY 2026 Budget. He answered questions from the commissioners regarding the budget as well as issues with properties, developers, buildings, landlords and tenants, and squatters.

Ward 5 Councilmember's Office

Oliver Stoute, Director of Constituent Services for Councilmember Zachary Parker's office, shared that Councilmember Parker has concerns about the FY 2026 proposed budget. He also reminded residents about the upcoming changes to Metrobus at the end of the month. Mr. Stoute also spoke about the public safety issues in Trinidad, and shared that the Councilmember's office is taking multiple steps in response to recent violence.
