Welcome & Reports

Due to technical difficulties with the hybrid meeting, the meeting started late and the recording (<u>available on Youtube</u>) didn't start until during Ms. Albert's presentation.

Adoption of the Agenda

Multiple changes to the agenda were proposed:

Comm. Sauceda-Guzman moved to amend the agenda as proposed. Second Roblin. Vote: 6-0-0.

Comm. Sauceda-Guzman moved to adopt the agenda as amended, as recently noticed to the public seven days in advance of the meeting. Second Roblin. Vote: 6-0-0.

Requested Presentation: Nina Albert, Deputy Mayor - RFK Stadium

Ms. Albert presented on behalf of the Mayor's Office regarding the proposed stadium deal that would bring the Washington Commanders NFL team back to the site of the former RFK Stadium in Ward 7. The proposed deal was reached by Mayor Bowser and the Washington Commanders, and it must be approved by the DC Council to move forward. Ms. Albert touched on some of the questions people have had about the proposed deal, including on the topics of parking and transportation, affordable housing, environmental impact, and job creation for city residents.

Treasurer's Monthly Report (7:56 PM)

Comm. McCray shared that as a result of a stale check, the OANC initiated an adjustment of \$9.54 to reverse Check #352, dated May 3, 2024, issued to Comm. Roblin. The check is stale and cannot be cashed. The

check will be reissued in the same amount; in accordance with OANC, ANC 5D does not need to re-vote on issuing the check. This information was required to be shared at a public meeting.

As of May 1, 2025, the ANC had received the OANC Q3 allotment. The beginning balance in May as of May 1 was \$52,130.69. There will be more information to share at the June monthly public meeting.

Comm. Arbuckle (5D01 – Union Market): Absent for Commissioner Reports. 5D01@anc.dc.gov

Comm. Rhodes (5D02 – Ivy City): Comm. Rhodes shared that the Ivy City Resiliency Plan Workshop #2 went very well. Workshop #3 will be June 14 at Lewis Crowe Park. An Ivy City environmental justice tour on Saturday, May 10 also went very well. Comm. Rhodes reminded residents to keep submitting 311 requests for illegal dumping, and send the 311 request number to your single member district (SMD) ANC commissioner or Comm. Rhodes. 5D02@anc.dc.gov

Comm. Roblin (5D03 – southern Trinidad): Comm. Roblin shared that she, along with several residents on the 1100 block of Morse St., have been circulating a petition for better lighting from the streetlamps. About two years ago, DDOT changed the bulbs in DC to more energy efficient bulbs, but the new ones don't provide enough light. This is affecting safety and traffic. If you'd like to advocate for better lighting on your block, contact your SMD commissioner. Comm. Roblin also shared that ANC 5D will be holding a spring health and resource fair on Saturday, May 31 from 11 AM to 2 PM at Starburst Plaza. Executive Office of the Mayor: Christian Starghill

Ms. Starghill shared three announcements:

- 1. The Mayor's Office is excited to announce full funding in Fiscal Year 2026 for the Pre-K Enhancement and Expansion Program (PKEEP), the Early Childhood Educator Pay Equity Fund, and the DC Child Care Subsidy Program.

Ward 5 Councilmember's Office: Andrianna Lovelace

Ms. Lovelace shared the following announcements:

Councilmember Parker will be joined by leadership from the Washington Commanders as well as Ms. Albert, the deputy mayor. Some of the other council members will be present as well. Regarding the RFK Stadium meeting, Comm. Rhodes asked: will Ward 5 community member and resident concerns be considered by Councilmember Parker when he decides how to vote? Ms. Lovelace responded that the event is targeted towards Carver Langston and Trinidad residents predominantly and the councilmember wants to hear your questions and concerns.

Comm. Sauceda-Guzman stated that it looks like Councilmember Parker is going to vote yes on the stadium, and requested that at the event he answer the question of how this project will accelerate gentrification in ANC 5D, which has been known as one of the last strongholds of affordable housing in the city.

Comm. Sauceda-Guzman moved to approve the consent calendar items as presented to the public seven days in advance, with tonight's amendment to add the request for 1704 West Virginia Ave NE. Second Roblin. Vote: 6-0-0.

Voting Actions (8:25 PM)

BZA #21292: 405 & 407 Morse St NE, Meridith Moldenhauer

This BZA case was presented twice to the ANC 5D Zoning Committee. The hearing date is May 21, 2025.

The proposed plan is to join the structures at 405 and 407 Morse St. NE to create one venue with an open floor plan, which will be used as an entertainment event space and music venue, with no restaurant or dining. The access will be in the rear of the building (in the alley) to allow the first floors to remain as retail. There has been discussion about the state of the alley and that it needs to be cleaned up. Ms. Moldenhauer stated that her client is working diligently to clean the alley up and continues to call 311 when improper dumping occurs in the alley.

Ms. Moldenhauer discussed the proposed security and operations plan, which included security cameras, additional lighting, and transportation coordination. She also discussed sound management, which will include soundproofing, speaker placement and sound system design, and operational policies.

The BZA relief requested is Special Exception Relief to permit entertainment, assembly, and performing arts use in the PDR-1 zone, as well as variance relief since there will be another live performance venue within 1,000 ft (the other venue is not yet open but will be at 400 Morse St NE; they presented at the ANC 5D public meeting in April). The Office of Planning is supportive of both the special exception and the variance relief.

Comm. Sauceda-Guzman stated that several ANC commissioners did a small walk in the alley where the entrance to the venue will be and it was full of dumpsters. They stated that the project seems very premature

since it involves activating that alley. Ms. Moldenhauer responded that access through the alley is a vision and requires the property owner to invest in the city; the alley doesn't look usable now, but with ANC support for the application before the BZA, there will be a transformation for the benefit of the community. Comm. Sauceda-Guzman requested plans, a blueprint, or some sort of work in action to ensure that that transformation occurs; they stated that they will be voting no as they think this project is very premature. Ms. Moldenhauer clarified that this is a preliminary stage, because the property owner needs to get approval for the proposed use of the site prior to completing additional work to prepare the site.

Comm. Arbuckle stated that he is supportive of the project and encouraged the other commissioners to vote in favor of it.

Comm. Rhodes asked if there was anything in the plans presented at this meeting that shows the alley cleaned up or redone? Ms. Moldenhauer stated that she showed a rendering of the future intent of the alley, and at the ANC 5D Zoning Committee meeting, there were questions raised about this and the client was present and did describe the effort they have been making. There were comments regarding illegal dumping in the alley and the client indicated that he had personally removed some of that material. The commissioners recommended that he not just remove the material but that he call 311 to create a paper trail, and the client has started to do that. Ms. Moldenhauer stated that photo evidence can be provided for the 311 requests.

Comm. Sauceda-Guzman moved to support BZA Case #21292. Second McCray.

Discussion: Comm. McCray wants to vote yes, but on the condition that we get to see renderings of what the alley will look like and that the owner will come back to give a status update and a walkthrough of the property prior to the opening of the establishment. Comm. Rhodes agrees with Comm. McCray. Ms. Moldenhauer stated that the conditions were acceptable and they would comply.

NY Ave Men's Shelter Update & Support, Tyler Edge, Meridith Moldenhauer, Suman Sorg, and Team

The Heritage will be the new men's shelter at 1201 New York Ave NE. The team presented an update on the building/site design; the project includes an approximately 400 bed facility with five distinct programs: working/employment initiatives, seniors/medically frail/medical respite, health clinic, low barrier services, and a daytime service center. Ms. Sorg, the architect, presented the architectural site plan. Ms. Moldenhauer shared information regarding the zoning for the site; she indicated that the building will be within the maximum allowed FAR, height, and lot occupancy, and will provide or exceed the required loading, bicycle parking, and vehicle parking quantity requirements for the amended zone.

Ms. Moldenhauer shared that the flexibilities being requested in order to meet the requirements for Zoning Map Amendment from RF-1 zone to MU-9 zone are: (1) all 42 parking spaces will be compact in order to maximize parking on the uniquely-shaped site so that sufficient parking is available for staff (MU-9 requires at least 50% of required spaces be full-size); (2) the loading berth will have a smaller dimension than required due to insufficient space on-site to allow for the appropriate turning radius for large trucks. Ms. Moldenhauer indicated that the primary loading needs of food deliveries, mail and packages, and trash will not require larger trucks. The project is seeking the Zoning Map Amendment to MU-9 since that is the first zone that allows a by-right shelter of this size.

Comm. Rhodes moved to support the Heritage, the new men's shelter. Second Roblin.

BZA: 400 Morse St NE, Lawrence Ferris

Mr. Ferris stated that the business he represents presented at the April public meeting and received approval for an eating and drinking establishment at 400 Morse St NE that will also have indoor performances inside on the first floor. He has returned to the ANC due to the 405 & 407 Morse St NE BZA application - 400 Morse St NE is now seeking support of variance relief due to being less than 1000 feet from another performance venue. While this approval may not be required, it was recommended out of an abundance of caution.

Comm. Sauceda-Guzman clarified that the two businesses are focused on different types of entertainment and cater to different audiences. 400 Morse St NE will be a restaurant with live performances as entertainment, while 405 & 407 Morse St NE will be an event space available for bookings.

Comm. Sauceda-Guzman moved that the commission support this project in its variance relief request. Second McCray.

Public Safety Report, Commander Rooney (MPD)

Commander Rooney shared that there has been a major uptick in motor vehicle theft and all crimes related to motor vehicles, and the police district serving ANC 5D is leading the city in motor vehicle crimes. He recommended not leaving items in sight in your car, getting an Airtag and/or "the club" anti-theft device, and not leaving your car unlocked. He shared that 60% of motor vehicle thefts in this police district are "hop-in" - he also recommended not leaving your keys in the car or leaving your car running at any point unattended. Commander Rooney also shared that there has been an uptick in carjackings and attempted carjackings.

Comm. McCray stated that there continue to be concerns about folks hanging out on Neal St by Staples and Orren Sts, and that it would be helpful for MPD to discuss potential approaches to this issue with the residents in that area. Commander Rooney stated that there are multiple approaches MPD can take, including noise ordinance violations.

Comm. Rhodes asked if MPD is still working on illegal dumping calls. Commander Rooney shared that while the environmental crimes unit does still work on these issues, they are backlogged and have been affected by DC's budget deficit that has prevented them from utilizing overtime.
