# Advisory Neighborhood Commission 6C Wednesday, June 11, 2025, 7pm WebEx Teleconference (see www.anc6c.org for information)

**Introductions**: Determination of Quorum and Community Welcome began at approximately 7:00 PM with 7 of 7 Commissioners present: Jeremiah Foxwell (6C01); Karen Wirt (6C02); Jay Adelstein (6C03); Mark Eckenwiler (6C04); Daniela McInerney (6C05); Andrew Hayes (6C06); Tony Goodman (6C07). Commissioner Eckenwiler oriented attendees to functions of the WebEx meeting platform.

**Approval of Agenda:** The publicly posted agenda was updated to account for a presentation on the Mayor's budget proposal, and to discuss 605 Constitution Avenue prior to the plenary agenda. Motion to approve by Wirt as amended: Unanimous **7-0-0**.

## Plenary Agenda

Planning, Zoning, and Economic Development Committee (Mark Eckenwiler, Chair)

- 1. 605 Constitution Ave. NE, HPA 25-281, Concept approval to construct a third-story addition to an existing one-story row dwelling with a two-story addition
  - a. Commissioner Eckenwiler provided an overview of issues debated in Committee, resulting in deadlocked votes and no recommendation to the ANC.
  - b. Architect Jennifer Fowler provided an overview of the applicant's plans, sight lines, and examples of precedent construction, as well as recent adjustments to account for community feedback.
  - c. Commissioner Adelstein noted that 10+ community comments opposing the development were circulated to all Commissioners prior to the meeting.
  - d. Seven Neighbors offered comments opposing the new structure based on aesthetic concerns.

Motion by Commissioner Hayes to support the proposal. After discussion and friendly amendments, Motion to support the construction as originally proposed, with a setback of the third story from the existing second story, and with aesthetic improvements discussed by Ms. Fowler based on Community Feedback: Motion Fails, **3-4-0**.

Commissioner Foxwell departs, 6 Commissioners present for remainder of meeting

The Commissioners considered alternative proposals and it appeared that none was likely to receive majority support from the present Commissioners.

Motion to Table by Wirt: Unanimous **6-0-0**.

Alcohol and Cannabis Licensing Committee

- 1. Washington Marriott Capitol Hill, 175 L Street NE, ABRA-121372, renewal, entertainment summer garden—Tony Goodman
  - a. Commissioner Goodman provided an update that this licensee is hosting "New York Style Rooftop Parties" with extremely loud music that is audible for blocks around, likely in violation of the requirements of their license.
  - b. Community members expressed concern that the hotel was repeatedly notified of this issue, and that the General Manager is choosing to continue these events without modification despite being repeatedly notified of neighbor concerns.

Motion by Commissioner Goodman to protest the renewal of the Marriott Hotel License, and designate Commissioner Goodman as representative to negotiate with the business: Unanimous **6-0-0**.
