### Advisory Neighborhood Commission 6E Virtual Public Meeting Wednesday, April 30, 2025

Jeanne Mattison provided updates from Councilmember Allen's Office relating to: **(1)** Resale Act bill; **(2)** Mayor's plans for reduced services and cut plans as a result of Congress not voting yet to fix the mistake and restore the \$1.1 billion in funding it cut; **(3)** Mayor's release of her proposed budget which is expected soon; **(4)** scheduling of Ward 6 Budget Town Hall; **(5)** Ward 6 Cleanup – thanks to everyone showing up.

## 5. UPDATE FROM MAYOR'S OFFICE OF COMMUNITY RELATIONS AND SERVICES (MOCRS) –

Noah Glasgow, Ward 6 Liaison

Noah Glasgow provided the following updates from the Mayor's Office relating to the Mayor's FY26 Budget Proposal: (1) addition of \$100M into the Housing Production Trust Fund; (2) \$19.5M to fully fund the pre-k enhancement and inspection and expansion program; (3) \$86M for the DC. Childcare subsidy program; (4) \$70M for the early childhood educator pay equity fund; (5) bringing the Washington Commanders back home to DC and redevelopment of the RFK site. A question-and-answer period followed.

10. UPDATE FROM THE D. C. DEPARTMENT OF HUMAN SERVICES ON E STREET BRIDGE HOUSING – 25 E STREET NW, WASHINGTON, DC 20001 POC: Tyler Edge

Tyler Edge provided an update on the E Street Bridge Housing which is scheduled to open in the Summer of 2025. He noted the generator is not attached to their building and they are looking for ways to brighten up the alleyway to ensure their residents and neighbors are safe. MOCRS Blitzes are proposed for May 15, 19, and May 20, 2025 at 6:30 p.m. He also advised the E Street Bridge Housing Community Advisory Team is being formed which will be a collaborative effort and opportunity between DHS, the service provider of E Street, ANC members, civic associations and residents to work together as a community. A question-and-answer period followed.

11. PRESENTATION FROM THE D.C. DEPARTMENT OF TRANSPORTATION ON NOI 25-193-MSED SAFETY IMPROVEMENTS ON  $6^{\text{TH}}$  STREET BETWEEN MASS AVENUE AND L STREET NW

A slide presentation was provided outlining safety improvements DDOT plans to implement on 6<sup>th</sup> Street between Massachusetts Avenue and L Street NW involving lanes reconfiguration, signal adjustment to add a new protected left turn phase and creation of a new left turning lane. A question-and-answer period followed.

**MOTION:** The Commission AGREED (4 yeas – 0 nays – 0 abstentions) to express support for the DDOT NOI 25-193-MSED Safety Improvements on 6<sup>th</sup> Street between Massachusetts Avenue and L Street NW. (Motion by Commissioner Prince, Second by Commissioner Hans).

- o Following the vote on the ABCA Liquor License Renewals, a constituent raised a concern with Busboys & Poets in that there is a high volume of car-based takeout that results in cars blocking the bike lane.
- Commissioner Abu-Khalaf stated we continue to work with Councilmember Allen's
  office and the Department of Buildings on a strategic plan for pressing maintenance
  issues in large multifamily buildings in 6E. He will start tracking some of these
  concerns that are being heard from constituents and will share that with
  commissioners.
- o Scott Lundberg stated he was noticing that there is a Youtube channel that ANC 6E used to use to post the meeting recordings, but it has been sort of inactive since last year. He wondered whether 6E has transitioned to a different platform. Commissioner Hans responded that that Youtube channel was connected to a former Commissioner's personal Gmail, which made things a little bit complicated, so we had to create a new Youtube channel. He has tried to transfer several of the videos but not all of them went through.
