GUEST PRESENTATIONS

Conner Laughland did not appear, as scheduled, to discuss pending Social Housing Development legislation. Commissioner D. Brown provided a summary of the proposed bill before the City Council, which intends to convert unoccupied and underutilized office spaces into affordable housing, particularly for low- to moderate-income residents.

The Department of Housing and Community Development (DCHD) Property Acquisition and Disposition Division (PADD) refused to appear to discuss the status of 199 Chesapeake Street—publicly-owned property to be disposed for private development. A solicitation was issued May 30, 2024, and a public hearing is scheduled for June 23, 2025 to announce the winning bid. (Letter from DCHD to the Commission is attached).

WMATA declined the Commission's invitation to present due to resource limitations prohibiting them from attending individual ANC meetings. Commissioners Nelson and E. Brown attended WMATA's meeting on May 10th for elected city officials. Metrobus routes and names will change effective June 29 as part of the Better Bus Network initiative. For more information, visit WMATA.com. Residents with concerns about bus

stops are encouraged to communicate with their respective ANC Commissioners, who will liaise with WMATA representatives.
