1. CALL TO ORDER AND ROLL CALL

The meeting was called to order at 6:30 p.m. with a quorum of 6 out of 6 Commissioners present.

Aukima Benjamin provided updates per the following: **(1)** residents should contact members of both Houses to urge the House to take up the Senate bill allowing DC to spend the \$1 billion that was approved by Congress for DC's FY25 budget; **(2)** the Mayor's FY26 Budget will be presented to the Council in the next couple of weeks with a vote expected in July/August; **(3)** proposed cuts to Medicaid; **(4)** Washington Teachers Union support of Councilmember Pinto's bill to ban cell phone use in schools during the school day; **(5)** Councilmember's Pinto's "Peace DC" plan to drive down crime; **(6)** Public Safety Forum in Ward 8 and Public Safety Walks in Wards 1, 2 and 7; thanks to Commissioners Garrett, Padro and Shea for attending the Ward 2 Walk; **(7)** Bike to Work Day, May 15, 2025; **(8)** World Pride: Our office will be marching in a parade down 14th Street to Pennsylvania Avenue NW on Saturday, June 7, 2025 at 1:00 p.m. A question-and-answer period followed.

E. Update from Department of Health – Loose Dogs

Joy Mcfarlane-Mills, Division of Animal Services, DC Department of Health

Commissioner Shea introduced the topic and stated there was an incident last week with dogs that were on the loose and one of them attacked another dog and injured it quite seriously. There have also been other incidents in the last few weeks to few years with other dog attacks in the area and the reporting and resolution of those has not been great.

Joy Mcfarlane-Mills joined the call to talk about this most recent incident and to also talk with community members about how to report these incidents. The contract is no longer with Humane Rescue Alliance. The new contract is with Brandywine Valley SPCA. Their phone number is 202-888-PETS (7387). The situation in question involved loose dogs that had gotten out of the home. This incident is currently being pursued as a potentially dangerous dog case and she advised that she is not at liberty to give out any further information on the case. She was asked to share any additional information along with contact information in the Chat. A question-and-answer period followed.

F. Advisory Neighborhood Commissioners

- o Commissioner Padro stated there was a series of alarms coming from the Carter G. Woodson Home at 1538-1542 9th Street NW. These were actually perimeter alarms and it was determined that there had actually been an intrusion into the building. Contractors have made some repairs there and the door that was used to gain access was also repaired. He shared the National Park Service phone number 202-610-7500 in the event anything else is noted related to those properties.
- Commissioner Nigro provided an update on 501 New York Avenue NW and stated the BZA did not reconsider the case. The question remains whether we want to go to the courts or not. She may present a motion at the end of the meeting.

MOTION:** Commissioner Nigro moved and Commissioner Padro seconded that ANC 2G apply for funding from the OANC Legal Assistance Fund so that ANC 2G can go before the Court of Appeals in regard to the case for 501 New York Avenue NW based on renegotiation with the OANC. The Motion **passed** 5 yeas 0 nays 1 abstention (Commissioner Garrett).
