CALL TO ORDER

Chair Gore called the meeting to order at 6:34 PM.

I. OPENING BUSINESS

A. MEETING PROCEDURES

Chair Gore outlined virtual meeting procedures.

B. ADOPTION OF AGENDA

The agenda was amended to correct the date from June 6 to June 9, add Lafayette school capacity discussion, and note RASE committee item for discussion at 8:45 PM. MOTION: To adopt the agenda as amended. Adopted unanimously (7-0).

C. ADOPTION OF MINUTES

II. REPORTS AND PRESENTATIONS

A. RESIDENT AND DC REPRESENTATIVES FORUM

Community members addressed bus schedule changes (John Wheeler), senior wellness center study (Karen Zuckerstein), and DC Attorney General upcoming civic engagement forums (Brian Heilman). Kendall Gibson (Ward 3 Manager, MOCRS, kendall.gibson1@dc.gov) announced office hours at the Chevy Chase Library on June 20th from 3:30 PM to 5 PM to address personal constituent issues.

B. PRESENTATIONS

- 1. "Beyond Gas" Presentation Students Marlie Alprin and Susie Gerety presented Sierra Club capstone project research on gas appliance health risks
- 2. Ward 3 Democrats Grant Request Deidre Brown, Chair, Ward 3 Democrats, requested \$2,000 for July 26 community outreach event (deferred for vote at next meeting)
- 3. Mayor's FY2026 Budget General Counsel Betsy Cavendish presented budget priorities including \$23.56M for Chevy Chase Library and \$14.796M for Community Center (shortfall of \$4.7M noted)

III. BUSINESS

A. DDOT SLIP LANE REMOVAL

Commissioner Grunewald presented a resolution addressing DDOT's Notice of Intent to remove right-turn slip lane at Broad Branch/27th Street and supporting traffic calming measures instead. DDOT, through its representative, Christine Mayeur, supported the resolution.

Amendment offered to soften the language of the resolution.

MOTION: Commissioner Grunewald moved to adopt resolution as amended. Motion seconded. Adopted (7-0).

B. LAFAYETTE SCHOOL CAPACITY

Commissioner Phinizy presented an analysis showing overcrowding concerns. Will draft formal letter to DCPS from the ANC requesting tour and capacity justification.

C. MARET FIELD TASK FORCE

Commissioner Sherman reported on final neighbor concerns. Maret Deputy Head Trey Holliday was present to speak to those concerns. Task force dissolution resolution to be introduced at July meeting.

D. TREASURER'S REPORT

MOTION: Commissioner Simmons moved to reimburse former Commissioner Ferguson \$99 for WP Forms subscription. Motion seconded. Adopted (4-0, 3 absent).

E. RASE COMMITTEE UPDATE

Commissioner Simmons announced the RASE meeting dates for the rest of the calendar and a 60-day call for new members (June 9 - August 8).

F. CIVIC CORE SURVEY UPDATE

Survey extended through June 29; 6,000 postcards/mailers sent to all household in ANC 3/4G.

G. SPECIAL MEETING

July 7, 2025, special meeting tentatively scheduled for civic core resolution discussion.

H. ADOPTION OF MINUTES

MOTION: Commissioner Nagy moved to adopt May 12, 2025, minutes with leave to make technical corrections. Motion seconded. Adopted (4-0, 3 absent).
