MOTION: Commissioner Fields moved for ANC 1b to protest Thurst Lounge on the grounds, peace, order, and quiet. Commissioner



Chauvin offered a friendly amendment to adding trash, litter, and noise provisions. Commissioner Fields accepted the amendment. The motion was seconded. Discussion occurred amongst commissioners on the best path forward to address concerns regarding noise and community complaints since Thurst Lounge is not up for renewal or seeking an endorsement. Commissioner Fields withdrew her original motion. Commissioner Kensek motioned that ANC 1B write a letter to ABCA issues of noise and complaints the community had regarding Thurst Lounge. The motion was seconded. DISCUSSION: Commissioner Sycamore suggested adding other agencies/entities to the letter i.e. Office of Night Life, DPW. The motion PASSED (6 in favor, 0 opposed, 0 abstention).

B. Committee on Economic Development

- i. 625 T St NW
 - 1. Park Zero" proposal: T Street Development has applied for a modified license for short-term use of this site, and for a modification to allow for electric vehicle charging.
 - 2. Committee recommendation: That the full ANC support the further development and submission of proposals both for a dog park and for fast-charging electric vehicle stations on the 625 T Street NW property, not precluding the development of alternative long-term proposals for the site; that ANC 1B encourage the immediate activation of the site as described by Mr. Jason Turner at this meeting; and that Commissioner Tucker Jones write a resolution to this end for ANC 1B's review and consideration (3-1-0).

MOTION: Commissioner Chauvin moved that the ANC support the concept and application for a dog park at 625 T St NW. The motion was seconded. **DISCUSSION:** Commissioner Kensek offered a friendly amendment suggesting that both proposals on the dog park and charging station be considered. Commissioner Chauvin did not accept the friendly amendment and suggested a different motion be raised later for the charging stations. **The motion DID NOT PASS (1 in favor, 6 opposed, 0 abstention).**

MOTION: Regarding the Economic Development Committee resolution, Commissioner Kensek moved that the full ANC respect and use what the Economic Development Committee came with to the table please. The motion was seconded. DISCUSSION: Commissioner Chauvin discussed his opposition to electrical vehicle charging stations and suggested a separate vote for a study. Commissioner Fields sought clarity on the committee's resolution. The motion PASSED (6 in favor, 1 opposed, 0 abstention).

REQUEST: Commissioner Fields also proposed that ANC 1B does 3 (\$1,000) scholarships to high-school students who will be attending post-secondary university, and 1 (\$3,000) scholarship to a college senior since we have a university in the area. **DISCUSSION:** Chair Harris and Commissioner Lakatos suggested going to OANC to seek additional clarity on ANC 1B funding educational scholarships, and also doing an amendment to the budget if it's possible to spend dollars scholarships.
