

Minutes of the March 18, 2025 meeting of Advisory Neighborhood Commission 1D

Meeting Call to Order

At 7:00 pm, Angela Allison, Chair, called the meeting to order. Seven of seven ANC1D commissioners joined the meeting at the outset of the meeting, representing a quorum. The meeting was publicly noticed through Facebook, Twitter, multiple widely subscribed community listservs, and a posting on www.anc1d.org. - Agenda Approval
 - Commissioner Wyers motioned to approve the agenda, including the consent agenda, and Commissioner Parbhoo seconded. The Chair called a voice vote, and the agenda was approved 7-0-0.

DC Governance and Other Presentations:

- Captain Jessica Hawkins provided a public safety update from MPD Third District.
- Lt. Randolph provided a public safety update from the MPD Fourth District (Note: this happened during the New Business section as Lt. Randolph joined the meeting late).

Old Business:

- **Update on Amigos Park**
 - Commissioner Allison and Commissioner Wyers offered an updated on Amigos Park.

New Business:

- **Pre-K Enhancement and Expansion Program (PKEEP) Funding Resolution**
 - Motion from Commissioner Patrick to approve the edited version of the resolution and Commissioner Núñez seconded. The Chair called a voice vote, and the motion passed 7 0-0.

- **Resolution Responding to the 1807 Newton St NW Fire Tragedy with Stronger Fire Safety Enforcement and Tenant Protection**
 - Motion from Commissioner Parbhoo to approve the edited version of the resolution and Commissioner Decker seconded. The Chair called a voice vote, and the motion passed 7 0-0.
- **Columbia Heights Neighborhood Management Zone**
 - Commissioner Decker provided an update on the proposed Columbia Heights Neighborhood Management Authority. Commissioner Decker also asked Niccole Rivero from CM Nadeau's Office to offer additional information on a Council bill to create a Neighborhood Management Authority in Columbia Heights.

Grants Business:

- Commissioner Núñez offered an update on the grants timeline and explained that the next application due date is Sunday, June 1; Sunday, September 1; Sunday, November 31st.
- Commissioner Wyers offered a budget update related to grants.

Committee Reports:

- Commissioner Parbhoo gave an update on the Committee of the Whole.

Treasurer's Report:

- Commissioner Wyers provided an update on the budget.
 - This report included some updated information on the Q2FY24 financial report. OANC did an audit of this report and found a reporting error. That error has been corrected, and Commissioner Wyers explained that the ending balance for Q2FY24 should have been \$71,366.03 and the opening balance for Q3FY24 should have been \$71,416.03.

Secretary's Report:

- Commissioner Patrick provided an update on the ANC mailing list.

Commissioner Updates:

- Commissioner Decker noted that DDOT has published a Notice of Intent for a new signal at 16th Street NW and Spring Place. There is also a DDOT Notice of Intent that there will be no left turn at Irving on 16th Street. Public input for both of those notices are due in April.
- Commissioner Falk offered information about an ANC1D housing project to collect constituent stories around housing and tenant needs. Commissioner Falk also flagged upcoming events on Lamont Plaza.
- Commissioner Núñez identified upcoming events in April. Commissioner Nunez also shared an update on DC compost waste bins.
- Commissioner Allison provided an update on the Park Regent building.

Meeting Adjournment:

With no additional comments or questions, Chair Allison requested a motion to adjourn. Commissioner Decker moved to adjourn the meeting, Commissioner Wyers seconded.

Commissioner Allison adjourned the meeting at 8:56 pm.
